Auditor/Treasurer/Coordinator Darren Esser, Drainage Manager Merissa Lore, and Acting Clerk to the Board Sarah Van Moer also attended. Faribault County employee J. Blair attended virtually.

Loveall/Young motion carried unanimously to approve the November 16, 2021 drainage authority agenda.

Groskreutz/Young motion carried unanimously to approve paying the drainage voucher bills totaling \$50,380.24.

Young/Loveall motion carried unanimously to adopt Resolution 21-DA41-109 setting a final acceptance hearing for the CD60 open ditch repair on December 21, 2021 at 11:00am in the boardroom. Commissioners Groskreutz, Young, Anderson, Loveall, and Roper voted yes.

- 4. The repair report was filed with the Faribault County Auditor on June 1, 2020.
- 5. The repair project was ordered by the Faribault County Board of Commissioners on July 7, 2020.
- 6. The repair project was advertised for bid and awarded to Brunz Construction Company, Inc. on October 6, 2020.

- 7. The final engineer's report and notice that the contract for construction of the open ditch repair project on County Ditch #60 is complete was received on November 15, 2021.

- 5. The repair project was ordered by the Faribault County Board of Commissioners on July 7, 2020.
- 6. The repair project was advertised for bid and awarded to Brunz Construction Company, Inc. on October 6, 2020.
- 7. The final engineer's report and notice that the contract for construction of the open ditch repair project on Judicial Ditch #2 is complete was received on November 15, 2021.
- 8. Pursuant to Minn. Stat. § 103E.555, public hearing must be held and noticed by mail at least 10 days in advance to owners of property and political subdivisions affected by the drainage project.

Based on the foregoing Findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for Judicial Ditch #2 hereby orders as follows:

- 3. On May 21, 2019, the Drainage Authority appointed Mark Origer of ISG as the engineer for the project.
- 4. On August 27, 2019, a Preliminary Hearing was held on the Preliminary Engineer's Report.
- 5. On September 3, 2019, Findings and Order for a detailed survey and detailed survey report were filed in the Faribault County Auditor's Office approving the Preliminary Engineer's Report, ordering a detailed survey report, and appointing viewers for the project.
- 6. The Faribault County Board of Commissioners met on July 7, 2020, in regular session to determine the date, time, and location for a final hearing on the project.
- 7. The Engineer's final detailed survey report was filed with the Faribault County Auditor on May 28, 2020.
- 8. A final hearing was held on July 30, 2020, after proper publication, posting, and notification. The drainage authority adopted findings and order to accept the final detailed survey report and ordered the engineer to proceed with project specifications, contracts, and bidding to construct the project.
- 9. The improvement project was advertised for bid and awarded to Trevor Leland Drainage & Excavating on September 15, 2020.
- 10. The closeout engineer's report and notice that the contract for construction of the improvement project on County Ditch #514 is complete was received on February 15, 2021.

11. Pursuant to Minn. Stat. § 103E.555, public hearing must be held and noticed by mail at least 10 days in advance to owners of property and political subdivisions affected by the drainage project.

Based on the foregoing Findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for County Ditch #514, hereby orders as follows:

- B. At least ten days before the hearing, the Faribault County Auditor shall mail notice of the time and location of the hearing to petitioners, owners of property, and political subdivisions likely to be affected by the drainage project.

- 5. The repair project was ordered by the Faribault County Board of Commissioners acting as the drainage authority for County Ditch #25A on January 22, 2021.
- 6. Viewers were appointed on July 6, 2021 to determine damages due to expected permanent and temporary damages caused by the project.
- 7. The repair project was advertised for bid and awarded to Krueger Excavating of Albert Lea, LLC on April 20, 2021.
- 8. The final engineer's report and notice that the contract for construction of the repair project on County Ditch #25A is complete was received on October 12, 2021.
- 9. The viewers filed the viewers' report on October 28, 2021.

10. Pursuant to Minn. Stat. § 103E.555, public hearing must be held and noticed by mail at least 10 days in advance to owners of property and political subdivisions affected by the drainage project.

Based on the foregoing Findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for County Ditch #25A, hereby orders as follows:

- A. A hearing for final acceptance of the repair project shall be held on December 21, 2021 at 1:30 pm at the Board Room of the Faribault County Courthouse, 415 North Main Street Blue Earth, MN 56013.
- B. At least ten days before the hearing, the Faribault County Auditor shall mail notice of the time and location of the hearing to petitioners, owners of property, and political subdivisions likely to be affected by the drainage project.
