Young/Loveall motion carried unanimously to approve Resolution 20-DA09-17 an order to redetermine the CD514 benefits and damages. Commissioners Groskreutz, Loveall, Roper, Warmka and Young voted yes.

#### RESOLUTION

**BE IT RESOLVED** that the County Board of Commissioners approves the following findings and order to redetermine benefits for County Ditch 514 and appoint viewers.

### Findings:

- 1. The Faribault County Board of Commissioners is the drainage authority for County Ditch 514.
- 2. County Ditch 514 was originally established as part of Martin County and Faribault Judicial Ditch 14 in 1911. In 1975 the drainage authority established the ditch as Martin County and Faribault County Joint County Ditch 204. In 2007 the drainage authority divided the system into four systems. The outlet system was established as Faribault County Ditch 514.
- 3. The current benefits roll reflects the benefited properties, benefited areas, and benefit values as determined by viewers based on assumptions regarding the future use and drainage of said properties.
- 4. Since the 2007 County Ditch 514 redetermination of benefits and damages, land uses have changed in the benefitted area.
- 5. In the 2007 redetermination of benefits and damages outlet fees were assigned to several systems utilizing County Ditch 514 as an outlet. The outlet fees are disproportionate to the watershed areas draining into County Ditch 514.
- 6. Since the 2007 redetermination of benefits and damages, the benefited area of County Ditch 514 has changed.
- 7. The drainage authority held a public meeting on February 4, 2020 to discuss the need for a redetermination of benefits.

8.	The drainage authority finds that the conditions required for the initiation of a
	redetermination of benefits exist, that the current benefits and damages do not reflect
	the current land uses, the outlet fees are disproportionate, and the benefited areas have
	changed.

#### Order:

Based on the foregoing Findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for County Ditch 514, hereby orders as follows:

- A. The Board shall follow the procedures of Minn. Stat. §103E.351 to conduct a redetermination of benefits for County Ditch 514.
- B. That Mark Behrends, Dennis Distad, Bruce Ness, John Thompson, Robert Hansen, and Kendall Langseth are hereby appointed as viewers to redetermination and report the benefits and damages for County Ditch 514.
- C. The County Auditor-Treasurer shall execute an order designating a time and location for the first meeting of the viewers and mail to the viewers a copy of the Auditor-Treasurer's order along with a certified copy of this order.
