Young/Loveall motion carried unanimously to approve Resolution 23-DA41-84 for cleanup of drainage system accounts for JD14MF after division into systems JCD214MF, JCD314MF, JCD414MF, and CD514. Commissioners Groskreutz, Roper, Young, Loveall, and Anderson voted yes.

## RESOLUTION

- WHEREAS, The following drainage systems were redetermined in accordance with Minnesota Statute §103.351 (JD14MF, JCD204FM) and divided into four systems (JCD214MF, JCD314MF, JCD414MF, CD514) on November 20<sup>th</sup>, 2007. The benefit roll has been updated by the County Auditor-Treasurer,
- **WHEREAS,** The Faribault County current account balances in the former drainage systems have been considered.
- **WHEREAS,** There are several accounts associated with the former systems. Main maintenance accounts used for system wide repairs and project specific accounts.
- WHEREAS, The projects have been constructed and completed.
- WHEREAS, Consolidating the accounts into one main account for each drainage system as detailed in the table below will result in more efficient accounting for the system.
- **WHEREAS,** Based on the record before it, the Board determines an equitable distribution of current funds be made as follow:
  - Funds remaining in the former JCD204FM Improv #1 (IFS #754) account shall be transferred to the JCD214MF main maintenance account (IFS #764)
  - Funds remaining in the former JCD204 Br T-29 Imp (IFS #762) account shall be transferred to the JCD214MF main maintenance account (IFS #764)
  - Funds remaining in the former JD14MF Improv (IFS #734) account shall be transferred to the JCD414MF main maintenance account (IFS #766)
  - Funds remaining in the former JD14MF Br E Improv (IFS #735) account shall be transferred to the JCD414MF main maintenance account (IFS #766)
  - Funds remaining in the former JCD204MF Br A38 (IFS #756) account shall be transferred to the JCD414MF main maintenance account (IFS #766)
  - Funds remaining in the former JD14MF (IFS #733) and JD14MF Improv (IFS #753) accounts shall be divided among the divided accounts for JCD214MF, JCD314MF, JCD414MF, and CD514 based on acres of watershed in Faribault County as follows:
