National Crime Victims' Rights Week, April 23-29, 2023

Survivor Voices: Elevate. Engage. Effect Change.

- Whereas the term "victim" is more than just a label and has legal standing and protections that go along with it;
- Whereas crime victims' rights acts passed here in Minnesota and at the federal level guarantee victims the right to meaningfully participate and use their voice in the criminal justice process;
- **Whereas** victim service providers, advocates, law enforcement officers, attorneys, and other allied professionals can help survivors find their justice by enforcing these rights;
- Whereas the right to provide an impact statement ensures that victims' voices are considered in court during the sentencing and, when applicable, restitution processes;
- **Whereas** including and elevating the voices of survivors makes certain they are heard and seen and creates a path to forging and sustaining community trust;
- Whereas engaging survivors creates responses and services that are credible, meaningful, and centered on individual needs;

CONDITIONAL USE PERMIT

Center Creek Gun Club, Inc. Verona Township, Section 8 & 9-103-28 #03-23-83

WHEREAS: According to the Faribault County Zoning Ordinance, Center Creek Gun Club, Inc. has requested a Conditional Use Permit for a Gun Club.

The proposed project is located in the A-1 Ag District located in:

That part of the Southeast Quarter of the Southeast Quarter of Section 8 and the Southwest Quarter of the Southwest Quarter of Section 9, Township 103 North, Range 28 West, Faribault County, Minnesota, described as follows: Beginning at the Southwest corner of said Section 9; thence on an assumed bearing of North 0 degrees 24 minutes 34 seconds West, along the west line of said section a distance of 151.00 feet; thence North 11 degrees 29 minutes West a distance of 77.00 feet; thence North 28 degrees 05 minutes West a distance of 87.00 feet; thence North 47 degrees 55 minutes West a distance of 147.50 feet; thence North 34 degrees 50 minutes East a distance of 101.00 feet; thence North 23 degrees 11 minutes East a distance of 97.26 feet to a survey monument; thence North 85 degrees 00 minutes East a distance of 376.99 feet to an iron monument; thence North 57 degrees 00 minutes East a distance of 80.00 feet to an iron monument; thence North 39 degrees 00 minutes East a distance of 348.00 feet to an iron monument; thence North 73 degrees 00 minutes East a distance of 275.00 feet to an iron monument; thence North 82 degrees 00 minutes East a distance of 468.28 feet, more or less to the east line of the Southwest Quarter of the Southwest Quarter of said Section 9; thence southerly, along said east line, a distance of 110 feet, more or less, to the centerline of Center Creek; thence westerly and southwesterly, along said centerline a distance of 1650 feet, more or less, to the south line of said section; thence westerly, along said south line, a distance of 252 feet, more or less, to the point of beginning, containing 10 acres, more or less, subject to easements now of record in said county and state.

WHEREAS:

According to the Faribault County Zoning Ordinance, Section 16 – Subdivisions (4–6), the Planning Commission has made its recommendation based on findings with respect thereto and all facts in connection therewith and has designated conditions deemed necessary for the protection of public interest.

WHEREAS: The Planning Commission finds that:

- 1. The proposed use of the property will not have an adverse impact on health, safety and the general welfare or be injurious to the use and enjoyment of other properties and residents for purposes already permitted in the surrounding neighborhood.
- 2. The proposed use meets the standards of the Faribault County Zoning Ordinance including that the use is allowed with a Conditional Use Permit in the designated zoning district in which it is proposed.
- 3. The proposed use will not have an adverse impact on traffic conditions, or that additional measures are being proposed in regard to access roads, traffic conditions, traffic congestion, and traffic hazard.

- 4. There are adequate public or private facilities and services in place or are being proposed to support the proposed use in regard to water supply, electricity, sewer services, lighting, public services, site drainage and off-street parking.
- 5. If the proposed use requires storage of materials, that adequate disposal measures are in place.
- 6. The proposed use will not have an adverse effect on the environment including impacts on the groundwater, surface water, soils, and air quality.
- 7. The proposed use will not substantially diminish and impair property values within the immediate vicinity and is compatible with the existing neighborhood.
- 8. The proposed use will not hinder the normal and orderly development and improvement of surrounding properties in the surrounding neighborhood for the uses predominate to the area.
- 9. The proposed use will have adequate measures in place to prevent or control offensive odors and/or fumes, dust, noise, and vibration, so that none of these will be a disturbance to neighboring properties.
- 10. If the proposed use requires any additional necessary facilities that they are identified in the permit.

NOW THEREFORE BE IT RESOLVED, that the Faribault County Board of Commissioners approve a Conditional Use Permit to Center Creek Gun Club, Inc. in the A-1 Ag District for a gun club with the following conditions:

- 1. All County, State, Federal laws, regulations, and ordinances shall be complied with, and site must be in compliance with all necessary permits.
- 2. No new structures shall be placed in designated floodplain areas as stipulated by the DNR.
- 3. Activities, safety, sound, rules, and hours of operation shall be in harmony with Minn. State Statute 87 A and the National Rifle Association (NRA) unless the Department of Natural Resources (DNR) adopts Shooting Range Performance Standards according to Statute.
- 4. Appropriate insurance shall be in place.
- 5. Parking shall comply with the Faribault County Zoning Ordinance, Section 15 General Regulations; A; and shall have a minimum of ten (10) parking spaces. If there is a large event, the computation of parking shall be one (1) space for every (4) people. There will be no parking on the County Highway.
- 6. Range rules shall be kept current with NRA and DNR standards and clearly posted throughout the range.
- 7. Future SSTS installation, accordance with Section 23 of the Faribault County Zoning Ordinance and MN Statutes 7080.

8. A review of the CUP will be completed by the Planning and Zoning Department every two years.
