WHEREAS, Faribault County has applied to the Commissioner of Transportation for a grant from the Minnesota State Transportation Fund for construction of Bridge No.22J63 on CSAH 1; and

WHEREAS, the Commissioner of Transportation has given notice that funding for this bridge is available; and

WHEREAS, the amount of the grant has been determined to be \$197,691.43 by reason of the lowest responsible bid;

NOW THEREFORE, be it resolved that Faribault County does hereby agree to the terms and conditions of the grant consistent with Minnesota Statutes, section 174.50, and will pay any additional amount by which the cost exceeds the estimate, and will return to the Minnesota State Transportation Fund any amount appropriated for the bridge but not required. The proper county officers are authorized to execute a grant agreement with the Commissioner of Transportation concerning the above-referenced grant.

Young/Groskreutz motion carried unanimously to approve Resolution 23-RB13-97 for the Local Bridge Replacement Program grant agreement on project SAP 022-602-029. Commissioners Groskreutz, Roper, Loveall, Young, and Anderson voted yes.

WHEREAS, Faribault County has applied to the Commissioner of Transportation for a grant from the Minnesota State Transportation Fund for construction of Bridge No.22J62 on CSAH 2; and

WHEREAS, the Commissioner of Transportation has given notice that funding for this bridge is available; and

WHEREAS, the amount of the grant has been determined to be \$207,012.06 by reason of the lowest responsible bid;

NOW THEREFORE, be it resolved that Faribault County does hereby agree to the terms and conditions of the grant consistent with Minnesota Statutes, section 174.50, and will pay any additional amount by which the cost exceeds the estimate, and will return to the Minnesota State Transportation Fund any amount appropriated for the bridge but not required. The proper county officers are authorized to execute a grant agreement with the Commissioner of Transportation concerning the above-referenced grant.

Roper/Young motion carried unanimously to approve Resolution 23-RB15-99 accepting the SP 022-598-011 Replace Bridge 9999 Project as completed and authorizing final payment to Midwest Contracting, LLC. Commissioners Groskreutz, Roper, Young, Loveall, and Anderson voted yes.

WHEREAS, SP 022-598-011 Replace Bridge 9999 Project has in all things been completed; and

WHEREAS, the final contract amount is \$475,810.00 which is \$4,109.00 (3.6%) more than the original contract bid of \$471,701.00; and

WHEREAS, to date \$452,019.50 has been paid to the contractor leaving the balance of \$23,790.50; and

WHEREAS, the work has been performed satisfactorily and all necessary forms have been completed and received by the Highway Department;

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners in and for the County of Faribault, Minnesota, that we do hereby accept said completed project and authorize final payment to Midwest Contracting, LLC.
