The Faribault County Board of Commissioners met pursuant to the recess of February 4, 2020 at the Courthouse in the City of Blue Earth at 9:00 a.m. on February 18, 2020. Young/Roper motion carried unanimously to approve Resolution 20-CB-18 approving Riverside Town and Country Club's application for a gambling permit. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

Drainage Manager Merissa Lore met regarding office business.

An update was presented on the CD21 improvement tile defect repairs. Four bid packages were opened. The low bidder on three of the four bids received was GRS Enterprises Inc. from Elgin, MN. Faribault County nor ISG has worked with GRS Enterprises Inc. in the past. ISG checked their references and they consisted of non-ag related projects including a housing development and park project. ISG had a phone conversation with them and said they had concerns with their references and asked if they had done ag tile work previously. GRS said they have done private tile work and worked with Fillmore County. ISG asked them to supply any tile reference they could by the end of the day. No further references were supplied. Staff called Fillmore and Wabasha Counties to see if either had worked with GRS in the past. Fillmore said they just came in wanting their contractor list and Wabasha County had never heard of them. Their website looks like they are mainly a roofing contractor.

Young/Loveall motion carried unanimously to accept the recommended bid for bid package #1 on CD 21 improvement tile defect repairs of \$109,587.67 from Noomen Excavating LLC. Other bids received were: GRS Enterprises Inc. of \$73,697.50, Brunz Construction of \$115,645.00, and Molnau Trucking LLC of \$120,100.00. Low bid was not awarded due to lack of ag tile experience, reference of work not related to the project, and the difficult nature of the project.

Roper/Young motion carried unanimously to accept the recommended bid for bid package #2 on CD 21 improvement tile defect repairs of \$67,424.00 from Brunz Construction. Other bids received were: GRS Enterprises Inc. of \$44,824.00, Noomen Excavating LLC of \$83,064.44, Molnau Trucking LLC of \$68,315.00, and Freeborn Construction Inc. of \$282,605.00. Low bid was not awarded due to lack of ag tile experience, reference of work not related to the project, and difficult nature of the project.

Loveall/Groskreutz motion carried unanimously to accept the low bid for bid package #3 on CD 21 improvement tile defect repairs of \$163,487.50 from Brunz Construction. Other bids received were: GRS Enterprises Inc. of \$243,111.00 and Noomen Excavating LLC of \$187,734.12.

Young/Roper motion carried unanimously to accept the recommended bid for bid package #5 on CD 21 improvement tile defect repairs of \$69,400.00 from Brunz Construction. Other bids received were: GRS

Enterprises Inc. of \$49,885.00 and Noomen Excavating LLC of \$78,583.96. Low bid was not awarded due to lack of ag tile experience, reference of work not related to the project, and difficult nature of the project.

Loveall/Young motion carried unanimously to accept low bid of \$44,814.00 from Krueger Excavating of Albert Lea for tree removal on CD 55 in Brush Creek and Emerald Townships. One other bid was received from Albert Lea Tree Service of \$132,405.00.
