The Faribault County Board of Commissioners met pursuant to the recess of March 3, 2020 at the Courthouse in the City of Blue Earth at 9:00 a.m. on March 17, 2020. The following members were present: Bill Groskreutz, Tom Loveall, John Roper, Tom Warmka, and Greg Young Commissioners. County Auditor/Treasurer/Coordinator Darren Esser, County Attorney Kathryn Karjala, Central Services Director Lexi Scholten, and Acting Clerk to the Board Clara Vereide were also present.

The meeting was called to order by Chair Warmka. The pledge of allegiance was recited.

Young/Groskreutz motion carried unanimously to approve the synopsis and official proceedings of the March 3, 2020 regular and drainage authority meetings.

Loveall/Roper motion carried unanimously to approve the agenda of March 17, 2020.

Committee reports were given. Loveall reported on Region Nine; Groskreutz reported on Department of Agriculture letter, township meetings, MVAC, Transit exec; Young reported township meeting; Roper reported on township meetings, Human Services meeting, MVAC, South Central Workforce; Warmka reported on township meetings, Soil and Water Board, GBERBA.

Brenda Baldwin of Blue Earth City Township met regarding defense of second amendment and requested board to declare Faribault County a second amendment dedicated county.

Loveall/Roper motion failed to approve resolution declaring to uphold and protect the Second Amendment as presented. Commissioners Loveall and Roper voted yes. Commissioners Groskreutz, Young, and Warmka voted no.

Young/Groskreutz to approve Resolution 20-CB-24 declaring to uphold and protect the Second Amendment with the change in the seventh paragraph of will to may. Loveall, Groskreutz, Young, Roper, and Warmka voted yes.

RESOLUTION

WHEREAS, the Second Amendment of the United States Constitution reads "A well-regulated Militia, being necessary to the security of a free state, the right of the people to keep and bear Arms, shall not be infringed." and

WHEREAS, the Faribault County Board of Commissioners wishes to express opposition to any law that would restrict the constitutional rights of the citizens of Faribault County to keep and bear arms;

THEREFORE, BE IT RESOLVED by the Board of Commissioners of Faribault County:

That the Faribault County Board of Commissioners hereby expresses its intent to uphold and protect the Second Amendment rights of the citizens of Faribault County, and

That the Faribault County Board of Commissioners hereby declares Faribault County as a "Second Amendment Dedicated County", and

That the Faribault County Board of Commissioners hereby declares its intent to oppose any infringement on the right of law-abiding citizens to keep and bear arms, and

That the Faribault County Board of Commissioners may refuse to appropriate any Faribault County resources to enforce any mandate, law, policy, order, or any other directive which infringes on the right of law-abiding citizens to keep and bear arms, and

That the Faribault County Board of Commissioners will use any legal means, including and without limitation, court action to protect the Second Amendment rights of the citizens of Faribault County.

Young/Roper motion carried unanimously to approve Resolution 20-CB-25 a symbolic declaration of principle to uphold the Minnesota constitution, United States constitution, and Bill of Rights within the confines of the law. Commissioners Loveall, Groskreutz, Young, Roper, and Warmka voted yes.

RESOLUTION

The Faribault County Board of Commissioners hereby makes the following Symbolic Declaration of Principle.

The Faribault County Board of Commissioners has sworn to uphold the Minnesota Constitution and the United States Constitution.

The Faribault County Board of Commissioners seeks to uphold all rights enumerated in the Bill of Rights, including the right to bear arms, for Faribault County Citizens.

The Faribault County Board of Commissioners will work within the confines of the law to protect the rights of all Faribault County Citizens, including the right to bear arms.

The Faribault County Board of Commissioners will continue to engage with Faribault County Citizens, encourage public discourse, and address Citizens' concerns as issues emerge and change.

- **WHEREAS**, during a health pandemic and/or emergency declaration, employees may be forced to be away from work for an extended period to protect themselves and others or to care for others; and
- **WHEREAS**, select Faribault County employees may benefit the employer by working solely or partially from outside of their normal work setting during said period.
- **THEREFORE, BE IT RESOLVED**, that the Alternative Work Arrangement Policy is now approved and available to select employees during health pandemic and/or emergency declarations per Chapter 12 of Minnesota State Statute.

Groskreutz/Young motion carried unanimously to approve Resolution 20-CB-27 Paid Time Off (PTO)/Leave emergency protocol. Groskreutz, Young, Roper, Loveall, and Warmka voted yes.

RESOLUTION

- **WHEREAS**, during a health pandemic and/or emergency declaration, employees may be forced to be away from work for an extended period to protect themselves and others or to care for others; and
- **WHEREAS**, Faribault County employees utilize paid time off and compensation earned banks to supplement their paychecks when away from work; and
- **WHEREAS**, not all employees have balances large enough to provide them with adequate income while away from work for an extended period.
- **THEREFORE, BE IT RESOLVED**, that the PTO/Leave Emergency Protocol is now approved and available to employees during health pandemic and/or emergency declarations per Chapter 12 of Minnesota State Statute.

WHEREAS, the final project cost is \$422,846.95 which is \$22,217.95 (5.3%) more than the original contract of \$400,629.00, and

WHEREAS, to date \$414,888.90 has been paid to the contractor leaving the balance of \$7,958.05, and

WHEREAS, the work has been performed satisfactorily and all necessary forms have been completed and received by the Highway Department.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners in and for the County of Faribault, Minnesota, that we do hereby accept said completed project and authorize final payment to the Midwest Contracting, LLC.

Young/Roper motion carried to reject sole bid for CP 20-600-08 for 2020 micro-surfacing from ASTECH for \$504,284.20.

Loveall/Groskreutz motion carried unanimously to accept quote from Arnold's of Alden of \$65,000 for a Case IH 150 A4 tractor after trade-in. Two other quotes were received from Smiths Mill Impl. Inc. of Smiths Mill for \$84,000 and Kibble Equipment of Blue Earth for \$108,500.

Roper/Young motion carried unanimously to accept quote of \$20,342.00 from Road Groom Manufacturing of Grundy Center, IA for a road groomer.

Loveall/Groskreutz motion carried unanimously to approve entering into a Joint Powers Agreement with City of Easton.

WHEREAS, the Faribault County Board of Commissioners has considered the application to repurchase the parcel and finds that it would be hardship for the owner to lose their home and that the repurchase would be in the public's best interest,

BE IT RESOLVED that Lynn Mehrhof-Hledik, the former owner of parcel #31.200.1710 described as the North Sixty-one feet (61') of Lot Eight (8), Block Fourteen (14), Original Plat, City of Winnebago, and also vacated strip ten feet (10') wide running North and South on East side of above North Sixty-one (61') of Lot Eight (8) be allowed to repurchase said parcel with the payment in full of the reinstated taxes, assessments, fees and costs as follows:
