- WHEREAS, Minnesota Statutes, Section 348.12, provides that the County Board of Commissioners may by resolution offer a bounty for the destruction of certain animals.
- **NOW, THEREFORE, BE IT RESOLVED**, that pursuant to said statute, there is paid a bounty of two dollars (\$2.00) for each pocket gopher destroyed and fifty cents (\$.50) to be paid for each striped and grey gopher destroyed in Faribault County during the year 2022.

Groskreutz/Anderson motion carried to amend per diems to \$40 per half day and \$80 per full day for citizen committee members, and set mileage reimbursement for citizen committee members, officials, and employees at the 2022 IRS rate of 58.5 cents per mile. Commissioner Loveall voted no.

Loveall/Anderson motion carried unanimously to approve citizen committee member appointments: Craig Beyer of Bricelyn to a 3-year term on Extension ending December 31, 2024; Ken Ripley of Blue Earth to a 3-year term on Extension ending December 31, 2024; Bill Groskreutz of Wells to a 5-year term on HRA ending 12-31-2026; Austin Bressler of Huntley to a 4 year term on Huntley Sewer board ending 12-31-2025; Andrew Moen of Blue Earth to a 3-year term on Library Board ending December 31, 2024; Julie Stenzel of Wells to a 3-year term on Library Board ending December 31, 2024; Russell Elmer of Wells to a 3-year term on Planning Commission ending December 31, 2024; and Dr. Aaron Johnson of Blue Earth to a 4-year term as Medical Examiner ending 12-31-2025.

Loria Rebuffoni met regarding Planning & Zoning business. Discussion was held regarding the decision of James Meyer to no longer serve on the planning commission and board of adjustment now that his term has ended, leaving a vacant seat. Rebuffoni stated that Eric Dahl had volunteered to take his place.

Anderson/Groskreutz motion carried unanimously to appoint Eric Dahl to the planning commission and board of adjustment for a 3-year term ending 12-31-2024.

Mark Daly met regarding public works business.

Loveall/Anderson motion carried unanimously to approve posting for a staff engineer position.

Loveall/Anderson motion carried unanimously to approve posting for two summer intern positions.

Roper/Groskreutz motion carried unanimously to approve posting for summer parks help.

Discussion was held regarding bonding. Esser stated that there may be a possibility of needing some additional bonding in 2022 for the Courthouse HVAC project and planned large improvements on some of the drainage systems.

Anderson motion died for lack of a second to bond for \$9 million towards road construction, and another \$1 million for drainage projects later, if needed.

Loveall motion died for lack of a second to bond for \$6.5 million towards road construction.

Anderson motion died for lack of a second to bond for \$8.5 million towards road construction.

Roper/Anderson motion carried to start the bond process for a \$10 million bond towards road construction. Commissioner Loveall voted no. Commissioners Anderson, Roper, Groskreutz, and Young voted yes.

Loveall/Roper motion carried unanimously to adopt Resolution 22-CB-02 selling a tax forfeited parcel to the City of Delavan to correct blight. Commissioners Anderson, Roper, Groskreutz, and Young voted yes.

RESOLUTION

- WHEREAS, Parcel No. 23.036.4100 forfeited to the State of Minnesota in favor of the Taxing Districts on November 16, 2020, and
- **WHEREAS,** the Faribault County Board of Commissioners has hereby classified the parcel as non-conservation property, and
- WHEREAS, said parcel has structures that are in a blighted condition and said blight has caused the value of the parcel to be reduced, and
- WHEREAS, the Faribault County Board of Commissioners has set the market value of said parcel at \$100.00 each, and
- WHEREAS, the City of Delavan has applied to the Faribault County Board of Commissioners pursuant to Minnesota Statute 282.01, Subd. 1a, par. (d) to purchase the parcel for the reduced value of \$1.00 and has documented that the city plans to correct blighted conditions via demolition on the property,
- **THEREFORE, BE IT RESOLVED** that the Faribault County Board of Commissioners hereby grants the request of the City of Delavan to purchase Parcel No. 23.036.4100 for \$1.00 plus any associated fees involved in the transaction.
