- **WHEREAS,** the Faribault County Board of Commissioners has considered the application to repurchase the parcel and finds that it would be a hardship for the owner to lose said parcel and that the repurchase would be in the public's best interest,
- **BE IT RESOLVED** that Sam Hicks, heir to the former owner of Parcel 31.250.0750 described as: Lots five (5), six (6), seven (7), eight (8), nine (9), ten (10), eleven (11), and twelve (12), in Block four (4) of College Addition to Winnebago City (now City of Winnebago), Minnesota, on file and of record in the Office of the Register of Deeds (now County

Recorder) of Faribault County, Minnesota be allowed to repurchase said parcel with the payment in full of the reinstated taxes, assessments, fees and costs as follows;
