## RESOLUTION

## AMENDMENT TO THE FEEDLOT ORDINANCE

#### THE COUNTY BOARD OF FARIBAULT COUNTY ORDAINS:

That SECTION 4: A – REQUIRED SETBACKS FOR LAND APPLICATION OF MANURE, of the Faribault County Feedlot Ordinance is amended as follows:

### 4. RESTRICTIONS ON LAND APPLICATION SITES

# A. Required Setbacks for Land Application of Manure

All feedlots shall meet the following setbacks for the land application of manure unless a land use plan approved by the SWCD recommends alternative distances.

Feedlots in Faribault County shall comply with the minimum standards set forth within the Minnesota Pollution Control Agency (MPCA) Chapter 7020 rules and updates. Unless Faribault County has established more restrictive standards.
