### Faribault County Opt Out of Vegetative Maintenance Form 2024

Landowners who do not approve of chemical application and/or mowing shall notify the Faribault County Drainage Department in writing each year. In addition, metal "No Spraying" signs must be installed on your property. The landowner will assume all responsibility to remove trees, brush, and weeds in the ditch right-of-way at their own expense. If upon inspection by the Drainage Department the removal of trees, brush, and weeds is not satisfactory, or if not removed by the date set, the Drainage Department may order chemical spray be applied or vegetation be mowed.
