System: County Ditch No. 60

Location: Jo Daviess Township Sections 1-3, 9-12, 15-16

Dear Landowner:

There will be an informational meeting held on **Tuesday, June 9th, 2020 at 11 am** on Faribault County Ditch No. 60 (CD60). A repair petition for open ditch cleaning and repairs was submitted on November 15th, 2018. Due to the benefits and damages not reflecting reasonable present-day land values and change in the benefited and damaged areas, a redetermination of benefits and damages was ordered for CD60 on August 6th, 2019. This meeting will cover the benefits and damage values, as well as the proposed repairs and associated costs.

Due to the pandemic with COVID-19, landowners can join this meeting 1 of the following 3 ways.
