Actual Results	<p>2014 - Gathered information from South Central Drainage Group on inspection process and data collection. Developed wireframes of mobile inspection app and desktop Drainage DB. Additions include gathering information and storing/tracking inspection data for repair, condition, violation, and BMP. Forms and process were developed for violation. The draft product was demonstrated to the Drainage DB User Group with great reviews and no additional comments from other counties. A hands-on training is planned for early 2015. Nearly all of the initial HEI programming is complete on the mobile app, with some work remaining on the desktop DB.</p> <p>2015 - A new version of Desktop DB was released and counties were trained November 18 through a user group meeting in New Ulm. The new version includes features for reporting things such as repairs, violations, conditions, and BMPs. Data created through the mobile app or desktop version can be exported to shapefile or excel. The mobile app development version is complete and waiting for comment from Faribault County's testing before release. This is anticipated in early 2016 and will allow users to collect and update data from the field.</p> <p>2016 - Version 2.1 of Drainage DB was released. A new button was added to the dashboard called "Annual Inspection Report." Tracking fields for Annual Inspections were added to the System Description tab allowing users to schedule next planned annual inspections by system and document past annual inspections. Drainage system list and export files were updated to include new tracking fields.</p>

Actual Results	<p>2014 - Through desktop Drainage DB and the mobile app, Faribault County has been working to create an inspection plan that will allow users to track previous inspection date, inspection findings, violation date, type, action, and continued inspection date. Previous inspections will be able to print a customizable summary report with maps and photos.</p> <p>2015 - All that remains is creation of a system wide Inspection Report by pulling information from multiple sources such as repairs, violations, BMPs and condition. The advance search is complete allowing users to search by various filters such as system name, type (violation, condition, BMP, repair), date, status, etc. A next scheduled inspection date is populated based on violation date or when a system was last inspected.</p> <p>2016 - Testing and coordination with HEI to release Drainage DB version 2.1 which enhanced and increased functionality regarding annual inspections.</p> <p>Staff Match 82 hrs * 45.72 - 2015 ML (2016)</p> <p>Staff Match 36 hrs * 54.44 - Q1 2016 ML</p> <p>Staff Match 18.5 hrs * 54.44 - Q2 2016 ML</p> <p>Staff Match 6 hrs * 54.44 - Q3 2016 ML</p> <p>Staff Match 27 hrs * 54.44 - Q4 2016 ML</p>
