#### Purpose

Public bids have been received for the upcoming repair work to portions of open ditch to Joint Judicial Ditch 49 (JD49). After reviewing all submitted bids with engineering staff from ISG, and Faribault County Drainage Staff, a list of applicable bidders has been tabulated (included in provided report).

A total of 8 contractors submitted bids, with bid numbers ranging from \$406,452.00 to \$576,928.65, with an engineer's estimate of \$565,384.13.

## **Requested Action**

We are asking the Joint Drainage Authority for Joint Judicial Ditch 49, to award the bid from Krueger Excavating of Albert Lea, LLC, in the amount of \$406,452.00 for the proposed planned repairs for portions of JD49.

On Wednesday, October 12, 2022, Bids were received for the Blue Earth/Faribault County JD 49 Repair. A total of eight bids were received ranging from \$406,452.00 to \$576,928.65. During the bid letting, ISG accepted all of the Contractors that provided the following bidding requirements.

- 5% Bid bond
- Prime Contractor Response Form (Responsible Contractor Form)
- First-Tier Subcontractor List
- Available Equipment List
- Reference List of similar work within the past 5 years.

The apparent low bidder for Blue Earth/Faribault County JD 49 is Krueger Excavating of Albert Lea with a base bid price of \$406,452.00. The Engineer's estimate at time of bid was \$565,384.13, for the base bid. Table 1, below for a summary of the bid results with a complete bid tabulation attached to this letter.
