## **Findings:**

- 1. A petition dated January 8, 2018, was received by the Faribault County Auditor requesting the impoundment, rerouting and diverting of public drainage system waters on Faribault County Drainage System 514 and a partial abandonment of parts of Faribault County Drainage System 514.
- 2. The drainage authority finds that is has jurisdiction over these proceedings and pursuant to Minn. Stat. §103E.227 and §103E.806 accepts the petition.
- 3. Pursuant to Minn. Stat. §103.227, the Petition requires appointment of an engineer to investigate the effect the need and estimated costs of the proposed project.

## Order:

Based on the foregoing Findings and the entire record of proceedings before the Board, the County Board acting as the drainage authority for CD514 hereby orders as follows:

- A. The Petition is hereby accepted.
- B. Mark Origer, ISG Group, is hereby appointed to investigate the petition and report of findings with the Faribault County Auditor.
- C. Upon the filing of the report of findings, the Auditor shall promptly notify the Board which will, in consultation with the Auditor, set a time, by order, not more than 30 days after the date of the order, for a hearing on the engineer's report of findings. The Auditor's shall provide notice of the public hearing on the report of findings in accordance with Minn. Stat. §103E.277 and § 103E.806.
