The Faribault County Board of Commissioners met via teleconference in the City of Blue Earth as the Faribault County Drainage Authority pursuant to the recess of the regular session on September 15, 2020. Young/Loveall motion carried unanimously to approve the low bid from Sellers Construction on JD7FM tile outlet and side inlet project totaling \$101,440.00.

Young/Groskreutz motion carried unanimously to approve the low bid from Trevor Leland Drainage & Excavating on the CD514 tile improvement project totaling \$36,606.80.

Loveall/Roper motion carried unanimously to reduce retainage to 2.5% on the CD3 open ditch repair, issuing payment of \$410,223.54 to Kreuger Excavating of Albert Lea, LLC.

Roper/Young motion carried unanimously to approve pay application #4 for CD55 open ditch repair to Brunz Construction for \$5,700.00.

Young/Roper motion carried unanimously to approve pay application #1 for CD21 tile defect repairs bid package #1 to Noomen Excavating, LLC for \$31,724.82.
