RESOLUTION

CONDITIONAL USE PERMIT Northern Natural Gas/Jeffrey Pfaffinger Jo Daviess Township, Section 12-102-28 #02-24-89

WHEREAS: According to the Faribault County Zoning Ordinance, Northern Natural Gas/Jeff Pfaffinger have requested a Conditional Use Permit for a Natural Gas Substation.

The proposed project is located in the A-2 Agriculture District located in:

Real property situated in the County of Faribault, State of Minnesota, and described as follows:

Northeast Quarter of Section 12, Township 102 North, Range 28 West, Faribault County, Minnesota. Said easement is described as follows:

A perpetual easement for pipeline facilities purposes over, under, and across that part of the Northeast Quarter of Section 12, Township 102 North, Range 28 West, Faribault County, Minnesota. Said easement is described as follows:

Commencing at the northeast corner of said Northeast Quarter; thence South 00 degrees 11 minutes 58 seconds West. bearings based on the Faribault County, MN coordinate system, along the east line of said Northeast Quarter, a distance of 2002.05 feet; thence North 89 degrees 48 minutes 02 seconds West, a distance of 33.00 feet to the westerly right-of-way line of 370th Avenue and the point of beginning of said easement to be described; thence South 00 degrees 11 minutes 58 seconds West, along said westerly right-of-way line, a distance of 150.00 feet; thence North 89 degrees 48 minutes 02 seconds West, a distance of 125.00 feet; thence North 00 degrees 11 minutes 58 seconds East, a distance of 150.00 feet; thence South 89 degrees 48 minutes 02 seconds East, a distance of 125.00 feet to the point of beginning.

EXCEPTING THEREFROM:

The Valve Site Easement as described in Doc. No. 335997 & 335604 which is described as follows:

A perpetual easement for pipeline purposes over, under and across that part of the Northeast Quarter of Section 12, Township 102 North, Range 28 West, Faribault County, Minnesota, described as follows: Commencing at the northeast corner of said Northeast Quarter of Section 12; thence South 00 degrees 11 minutes 58 seconds West, bearings based on Faribault County, Minnesota Coordinate System, along the east line of said Northeast Quarter a distance of 2101.87 feet; thence North 89 degrees 48 minutes 02 seconds West a distance of 53.72 feet to a set rebar marked with P.L.S. No. 22033 and the point of beginning of said easement to be described; thence South 26 degrees 04 minutes 06 seconds East a distance of 30.00 feet to a set rebar marked with P.L.S. No. 22033; thence South 63 degrees 55 minutes 54 seconds West a distance of 30.00 feet to a set rebar marked with P.L.S. No. 22033; thence North 26 degrees 04 minutes 06 seconds West a distance of 30.00 feet to a set rebar marked with P.L.S. No. 22033; thence North 63 degrees 55 minutes 54 seconds East a distance of 30.00 feet to said point of beginning.

- **WHEREAS:** According to the Faribault County Zoning Ordinance, Section 16 Subdivisions (4–6), the Planning Commission has made its recommendation based on findings with respect thereto and all facts in connection therewith and has designated conditions deemed necessary for the protection of public interest.
- **WHEREAS:** The Planning Commission finds that:
 - 1. The proposed use of the property will not have an adverse impact on health, safety and general welfare or be injurious to the use and enjoyment of other properties and residents for purposes already permitted in the surrounding neighborhood.
 - 2. The proposed use meets the standards of the Faribault County Zoning Ordinance including that the use is allowed with a Conditional Use Permit in the designated zoning district in which it is proposed.

- 3. The proposed use will not have an adverse impact on traffic conditions, or that additional measures are being proposed in regard to access roads, traffic conditions, traffic congestion, and traffic hazard.
- 4. There are adequate public or private facilities and services in place or are being proposed to support the proposed use in regard to water supply, electricity, sewer services, lighting, public services, site drainage and offstreet parking.
- 5. If the proposed use requires storage of materials, that adequate disposal measures are in place.
- 6. The proposed use will not have an adverse effect on the environment including impacts on the groundwater, surface water, soil, and air quality.
- 7. The proposed use will not substantially diminish and impair property values within the immediate vicinity and is compatible with the existing neighborhood.
- 8. The proposed use will not hinder the normal and orderly development and improvement of surrounding properties in the surrounding neighborhood for the uses predominate to the area.
- 9. The proposed use will have adequate measures in place to prevent or control offensive odors and/or fumes, dust, noise, and vibration, so that none of these will be a disturbance to neighboring properties.
- 10. If the proposed use requires any additional necessary facilities that they are identified in the permit.
- NOW THEREFORE BE IT RESOLVED, that the Faribault County Board of Commissioners approve a Conditional Use Permit to Northern Natural Gas/Jeffrey Pfaffinger in the

A-2 Agriculture District for a natural gas substation with the following conditions:

- 1. All County, State, Federal laws, regulations, and ordinances shall be complied with, and the site must be in compliance with all necessary permits and setbacks.
- 2. Applicants must apply for an E911 address.
- 3. Applicants must apply for a Zoning permit prior to any construction.
- 4. A review of the CUP will be completed by the Planning and Zoning Department every two years.

RESOLUTION

Authorization to submit a proposal to Minnesota IT Services Office of Minnesota Geospatial Information (MnGeo) for a project to restore, maintain, and update Public Land Survey System (PLSS) land corners in Faribault County, Minnesota.

WHEREAS, in 2023 the Minnesota Legislature, through MN Statute §381.125, directed the Minnesota Geospatial Information Office (MnGeo) to develop a grant program for the perpetuation of Public Land Survey System (PLSS) monuments; and

WHEREAS, Faribault County is responsible for maintaining the PLSS; and

WHEREAS, Faribault County has identified T101N R26W and T104N R24W as a project area; and

WHEREAS, the proposal titled "Faribault County T101N R26W + T104N R24W Remonumentation Project" may request up to the amount of \$300,000 in grant funding to restore, maintain and update PLSS land corners.

NOW THEREFORE, BE IT RESOLVED, that the Faribault County Board of Commissioners authorizes the appropriate county officials to submit a proposal to MnGeo for the Minnesota PLSS Monument Grant Program and if awarded, authorizes the appropriate county officials to accept the grant and enter into the necessary agreements beginning in February 2024 and running through March 31, 2026.

 - b. provide a list of all transactions made by electronic fund transfer to the County Board at its next regularly scheduled meeting.
