- **NOW, THEREFORE, BE IT RESOLVED,** that Faribault County grants consent to continue accepting the initial resettlement of refugees within its borders until withdrawn as per the terms of Executive Order 13888; and
- **BE IT FURTHER RESOLVED,** that the Faribault County Auditor/Treasurer/Coordinator will hereby notify the United States Department of State of Faribault County's consent by January 21, 2020.
