The following members were present: Bill Groskreutz, Tom Loveall, John Roper, Tom Warmka, and Greg Young Commissioners. County Auditor/Treasurer/Coordinator Darren Esser, County Attorney Kathryn Karjala, and Acting Clerk to the Board Clara Vereide were also present.

The meeting was called to order by Chair Groskreutz. The pledge of allegiance was recited.

Warmka/Young motion carried unanimously to approve the synopsis and official proceedings of the September 3, 2019 regular and drainage authority meetings.

Loveall reported on Region Nine and AMC Fall Policy meeting; Young reported on Human Services exec and Transit exec; Roper reported on AMC Fall Policy meeting, Human Services exec, Career Force, and MVAC; Groskreutz reported on Community Health, MRCI, Transit exec, AMC Fall Policy meeting, and MVAC.

- **BE IT RESOLVED** that Jodell Sanders, the former owner of Parcel No. 25.033.0170 described as Auditor Lot 77 except the street in the City of Elmore, Faribault County, Minnesota. Section 33-101-027 be allowed to repurchase said parcel with the payment in full of the reinstated taxes, assessments, fees and costs as follows;

WHEREAS, SAP 022-599-111, 480th Avenue bridge project has in all things been completed; and

WHEREAS, the final project amount is \$210,097.33 which is \$6,759.33 (3%) more than the original contract bid of \$203,338.00; and

- WHEREAS, SAP 022-599-112, 60th Street Bridge project has in all things been completed.
- WHEREAS, the final project amount is \$482,138.70 which is \$22,096.70 (5%) more than the original contract bid of \$460,042.00; and
- WHEREAS, SAP 022-599-113, 425th Avenue bridge project has in all things been completed; and
- **WHEREAS,** the final project amount is \$188,930.43 which is \$2,330.43 (1%) more than the original contract bid of \$186,600; and
- WHEREAS, the final contract amount for all three projects is \$881,166.46 which is \$31,186.46 (3.7%) more than the original contract bid of \$849,980.00; and
- WHEREAS, to date \$880,202.18 has been paid to the contractor leaving the balance of \$964.28; and
- **WHEREAS,** the work has been performed satisfactorily and all necessary forms have been completed and received by the Highway Department.
- **NOW, THEREFORE BE IT RESOLVED** by the Board of Commissioners in and for the County of Faribault, Minnesota, that we do hereby accept said completed projects and authorize final payment to Midwest Contracting, LLC.

MNDOT TH 254 commencing at the intersection of south right of way line of the Chicago and Northwestern Railroad in the City of Frost, and terminating at the north ramps of i-90, a distance of 4.8 miles shown in attached Exhibit A.

Be, and hereby is established, located and designated in County State Aid Highway 17 of said County, subject to the approval of the Commissioner of Transportation of the State of Minnesota.

BE IT FURTHER RESOLVED, that the County Auditor is hereby authorized and directed to forward a certified copy of this resolution to the Commissioner of Transportation for consideration, and that upon his approval of the designation of said road or portion thereof, that same be contracted, improved and maintained as a County State Aid Highway of the County of Faribault to be numbered and known as County State Aid Highway 17.

Warmka/Roper motion carried unanimously to approve Resolution 19-RB13-44 designating Trunk Highway 253 as CSAH 23. Commissioner Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

MNDOT TH 253 commencing at the intersection of County State Aid Highway 2 in the City of Bricelyn and terminating at the intersection of County State Aid Highway 21, a distance of 6.562 miles shown in Exhibit A, and hereby is established, located an designated as County State Aid Highway 23 of said County, subject to the approval of the Commissioner of Transportation of the State of Minnesota.

BE IT FURTHER RESOLVED, that the County Auditor is hereby authorized and directed to forward a certified copy of this resolution to the Commissioner of Transportation for consideration, and that upon his approval of the designation of said road or portion thereof, that same be contracted, improved and maintained as a County State Aid Highway of the County of Faribault to be numbered and known as County State Aid Highway 23.

WHEREAS, the Faribault County Board of Commissioner has considered the financial needs of Faribault County,

- **BE IT THEREFORE RESOLVED,** that the budget of Faribault County for 2019 will be set at \$26,164,093 in revenues and \$26,154,076 in expenditures.
- **BE IT FURTHER RESOLVED** that a copy of said budget be kept on file in the Office of the County Auditor/Treasurer for public inspection.
- **BE IT THEREFORE RESOLVED** that the levy of Faribault County for 2020 will be set at \$12,651,173 before state aid reductions.
- **BE IT FURTHER RESOLVED** that the levy after reduction of program aid of \$699,300 be appropriated to the proper funds as follows:

Young/Loveall motion carried unanimously to approve Resolution 19-CB-46 to approve the findings and order to set public hearing for petition for a lateral and repair for CD 10. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

RESOLUTION

BE IT RESOLVED that the County Board of Commissioners approves the following findings and order to set public hearing for petition for a lateral and repair for County Ditch 10.

Findings

- 1. The Faribault County Board of Commissioners is the drainage authority for County Ditch 10.
- 2. On January 23, 2017, a petition for lateral to County Ditch #10 was received by the drainage authority.
- 3. On February 7, 2017, the drainage authority adopted findings and an order accepting the petition and appointing Chuck Brandel, I&S Group, Inc. as the project engineer. Chuck Brandel was ordered to prepare a preliminary survey and file a preliminary survey report with the drainage authority.
- 4. The preliminary survey report with an addendum was filed with the Faribault County Auditor on February 5, 2018.

- 5. Pursuant to Minn. Stat. § 103E.261, subd. 1, a public hearing must be noticed by mail to petitioners, owners of property, and political subdivisions likely to be affected by the proposed drainage project.
- 6. On May 18, 2018, a petition for repair of County Ditch 10 Branch 1 Lateral A was received by the drainage authority.
- 7. On June 19, 2018, the drainage authority adopted findings and an order accepting the petition and appointing Chuck Brandel, I&S Group, Inc. as the project engineer. Chuck Brandel was ordered to prepare a repair report and file the report with the drainage authority.
- 8. The repair report was filed with the Faribault County Auditor on April 9, 2019.
- 9. Pursuant to Minn. Stat. §103E.715 subd. 3, a public hearing must be noticed by mail to petitioners, owners of property, and political subdivisions likely to be affected by the proposed drainage project.

Order

Based on the foregoing findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for County Ditch 10, hereby orders as follows:

- a. A hearing on the preliminary survey report and repair report shall be held on October 7, 2019 at 9:00 a.m. at the Faribault County Ag Center conference room 415 South Grove Street Blue Earth, MN.
- b. At least ten days before the hearing, the Faribault County Auditor shall mail notice of the time and location of the hearing to petitioners, owners of property, and political subdivisions likely to be affected by the proposed drainage project in the preliminary survey report.

Loveall/Warmka motion carried unanimously to approve Resolution 19-CB-47 to approve the findings and order to set public hearing for petition to use CD 12 as an outlet. Commissioners Groskreutz, Loveall, Roper, Warmka, and Young voted yes.

RESOLUTION

BE IT RESOLVED that the County Board of Commissioners approves the following findings and order to set public hearing for petition to use County Ditch 12 as an outlet.

Findings

- 1. The Faribault County Board of Commissioners is the drainage authority for County Ditch 12.
- 2. On September 3, 2019, a petition for express authority to use County Ditch 12 as an outlet was received by the drainage authority.

3. Pursuant to Minn. Stat. §103E.401, subd. 3, a public hearing must be noticed by mail and noticed by publication.

Order

Based on the foregoing findings and the entire record of proceedings before the Board, the Board, acting as the drainage authority for County Ditch #12, hereby orders as follows:

- a. A hearing on the petition for express authority to use County Ditch 12 as an outlet for drainage shall be held on October 7, 2019 at 10:30 a.m. at the Faribault County Ag Center Conference Room 415 South Grove Street Blue Earth, MN.
- b. The Faribault County Auditor shall publish notice of the hearing at least once a week for three successive weeks in a legal newspaper in general circulation in each county affected by the notice. Notice by mail shall be sent to all benefited landowners on the drainage system concurrent with notice by publication.
- c. At least ten days before the hearing, the Faribault County Auditor shall give notice by mail of the time and location of the hearing to the owners of property and political subdivision likely to be affected by the project.
