The Faribault County Board of Commissioners met pursuant to the recess of January 5, 2021 in regular session via teleconference in the City of Blue Earth at 9:00 a.m. on January 19, 2021. The following members were present: Bruce Anderson, Bill Groskreutz, Tom Loveall, John Roper, and Greg Young Commissioners. County Auditor/Treasurer/Coordinator Darren Esser and Acting Clerk to the Board Clara Vereide were also present. Anderson/Groskreutz motion carried unanimously to approve Resolution 21-CB-03 granting an intoxicating on-sale liquor license with Sunday sales to Ann Erickson of the Golden Bubble in Foster Township. Commissioners Anderson, Groskreutz, Loveall, Roper, and Young voted yes.

RESOLUTION

- **WHEREAS,** Minnesota Counties have the authority to issue liquor licenses to establishments located in organized townships and;
- **WHEREAS,** Ann Erickson of the Golden Bubble located in Foster Township has applied for an on-sale intoxicating liquor with Sunday sales license and;
- WHEREAS, on January 6, 2021 the Foster Town Board approved issuance of said license and;
- **WHEREAS,** the Faribault County Board of Commissioners has considered the nature of the business to be conducted and its impact upon any municipality, the character and reputation of the applicant, and the propriety of the location.

NOW, THEREFORE, BE IT RESOLVED that an intoxicating on-sale liquor license with Sunday sales be granted, pending proof of proper liability insurance and commission approval, to Ann Erickson of the Golden Bubble located in Foster Township for the period of April 1, 2021 through March 31, 2022.

Loveall/Groskreutz motion carried unanimously to approve Resolution 21-CB-04 selling tax forfeited property to the City of Frost to correct blight. Commissioners Anderson, Groskreutz, Loveall, Roper, and Young voted yes.

RESOLUTION

- WHEREAS, Parcel No. 26.200.1010 and 26.200.1040 forfeited to the State of Minnesota in favor of the Taxing Districts on November 16, 2020 and November 9, 2018, respectively, and
- **WHEREAS,** the Faribault County Board of Commissioners has hereby classified the parcels as nonconservation property, and
- **WHEREAS,** said parcels have structures that are in a blighted condition and said blight has caused the value of the parcel to be reduced, and
- **WHEREAS,** the Faribault County Board of Commissioners has set the market value of said parcels at \$100.00 each, and
- **WHEREAS,** the City of Frost has applied to the Faribault County Board of Commissioners pursuant to Minnesota Statute 282.01, Subd. 1a, par. (d) to purchase the parcels for the reduced value of \$1.00 each and has documented that the city plans to correct blighted conditions on the property,
- **THEREFORE, BE IT RESOLVED** that the Faribault County Board of Commissioners hereby grants the request of the City of Frost to purchase Parcel No. 26.200.1010 and 26.200.1040 for \$1.00 each plus any associated fees involved in the transaction.

Groskreutz/Anderson motion carried unanimously to approve Resolution 21-CB-05 to levy 2021 ditch assessments as corrected. Commissioners Anderson, Groskreutz, Loveall, Roper, and Young voted yes.

RESOLUTION

- **WHEREAS,** Minnesota Statute 103E.705 subdivision 6, authorizes the County Board to levy assessments to meet the cost of ditch repair on county, judicial, and joint county ditches;
- WHEREAS, the County Board levied 2021 assessments via a resolution passed on December 15, 2020,
- WHEREAS, the County Auditor-Treasurer has identified errors in the December 15, 2020 resolution,
- WHEREAS, the County Board has reviewed the assessments prepared by the County Auditor-Treasurer,

- **THEREFORE, BE IT RESOLVED** that the assessments for more than one year be due and payable by December 31, 2020 and that unpaid balances at that time be charged a 4.0% annual rate of interest.
- **THEREFORE, BE IT resolved** that the following assessment list replace that list approved in the December 15, 2020 resolution.

Garth Carlson of Veteran Enterprises, LTD met regarding a resolution declaring that Faribault County has adequate resources to handle COVID-19. Faribault County Attorney Kathryn Karjala recapped her written opinion given to the board regarding the resolution request.

Loveall/Young motion failed to amend the resolution removing a section and the addition of four paragraphs from Commissioner Loveall. Commissioner Loveall voted yes. Commissioners Anderson, Groskreutz, Roper, and Young voted no.

Loveall/Young motion carried to approve Resolution 21-CB-06 supporting the rights of Faribault County citizens as expounded within the Constitution of the United States of America and the Minnesota State Constitution as amended. Commissioners Anderson, Loveall, and Young voted yes. Commissioners Groskreutz and Roper voted no.

RESOLUTION

- **WHEREAS,** Faribault County, Minnesota, recognizes that the Constitution of the United States, as well as the Constitution of the State of Minnesota, enshrines certain rights of all Americans, including those fundamental liberty interests set forth in the Fourteenth Amendment of the US Constitution that prohibit the state from depriving any person of life, liberty, or property without due process of law; and,
- **WHEREAS,** Faribault County recognizes that the US Declaration of Independence advances the "inalienable rights" of life, liberty, and the pursuit of happiness in the face of governmental overreach; and,
- **WHEREAS,** each of the Faribault County duly elected and appointed public servants took a sacred oath to preserve, protect and defend the US Constitution and the Constitution of the State of Minnesota; and,
- **WHEREAS,** Faribault County welcomes, honors and respects the contributions of all businesses and employees of said businesses, regardless of their size and regardless of whether they have been deemed "essential" by some government decree or not; and,
- **WHEREAS,** Faribault County's diverse and entrepreneurial businesses positively contribute to the economic, cultural and social fabric of the County; and,
- **WHEREAS,** agriculture and all businesses in the County have not only been a catalyst for the County's economic health, but have been the backbone of the County throughout its long history; and,
- **WHEREAS,** Faribault County businesses are socially responsible and are capable and willing to maintain adequate health protocols to ensure that Faribault County remains one of the most vital COVID-19 success stories in Minnesota; and,

- **WHEREAS,** fostering a relationship of trust, respect, and open communication between county officials and businesses is essential to the County's mission of delivering effective public services in partnership with the community, thereby advancing a high quality of life for residents; and,
- **WHEREAS,** Faribault County seeks to foster trust, not fear, between County officials and businesses and citizens, while properly allocating limited local resources and encouraging cooperation and open communication, to ensure public safety and due process for all, irrespective of business status; and,
- **WHEREAS,** Faribault County desires to demonstrate its commitment to its businesses and citizens by providing a safe community and by assuring them that, in accordance with federal and state laws and all state licensing authorities, the County will not of its own accord abridge such freedoms and rights; and,
- **WHEREAS,** Faribault County recognizes and honors the inalienable rights of individuals, as individuals, to earn a living, to employ others or to be employed, to provide income for their families, to give back to the community, to treat neighbors with respect and care, and contribute to the overall health and well-being of the community, without the need for undue government overreach, coercion, and control; and,
- **WHEREAS,** the Faribault County Board of Commissioners understands, respects, and has a duty to protect the United States Constitution and the Minnesota Constitution.
- WHEREAS, Minnesota Statute 12.31 Subd. 2. reads: "Declaration of peacetime emergency. (a) The governor may declare a peacetime emergency. A peacetime declaration of emergency may be declared only when an act of nature, a technological failure or malfunction, a terrorist incident, an industrial accident, a hazardous materials accident, or a civil disturbance endangers life and property and local government resources are inadequate to handle the situation.
- **THEREFORE BE IT HEREBY RESOLVED,** that the Faribault County Board of Commissioners supports the right of the citizens of Faribault County to freely avail themselves of those rights expounded within the Constitution of the United States of America and the Minnesota State Constitution.
- **BE IT FURTHER RESOLVED,** that the Faribault County Board of Commissioners acknowledges the ability of the individuals and business of Faribault County, to determine their best course of action to respond to the COVID-19 pandemic.
- **BE IT FURTHER RESOLVED**, that the Faribault County Board of Commissioners shall in accordance with Minnesota State law and United States of America federal law, exercise it's expressly granted powers to protect the constitutionally expounded rights of it's citizens.
