There will be a repair informational meeting on Faribault County Ditch #14 (CD14) held on **Tuesday, March 26th, 2024, at 12:30 pm at the Ag Center Conference Room** (415 South Grove Street Blue Earth, MN 56013). The Drainage Department completed an inspection and survey of CD14 in the summer of 2023. The inspection and survey indicate repairs are needed to portions of the open ditch. A Staff Repair Report was completed on the recommended repairs. 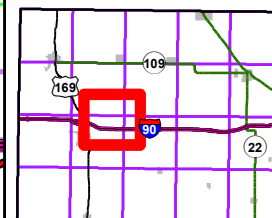

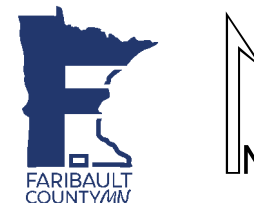
