There will be a final acceptance hearing on Faribault County Ditch #20 (CD20) Open Ditch Repair on Monday, June 28th, 2021 at 10:30 am at the Riverside Town and Country Club (36259 150th St. Blue Earth, MN 56013). A repair petition was filed on September 26th, 2016. The Faribault County Board of Commissioners, acting as the drainage authority for CD20, ordered repairs to CD20 open ditch on September 19th, 2017. The repairs were completed by Brunz Construction Company, Inc. during the 2019 growing season. The Engineer has certified the repair is complete. 
