RE: Improvement Defect Repairs Construction Completion Acceptance Hearing

Dear Landowner:

There will be an acceptance hearing on Tuesday, July 20th, 2021, at 1:00 pm at the Ag Center Conference Room (415 South Grove St. Blue Earth, MN 56013) on Faribault County Ditch #21 (CD21). An improvement petition was filed on July 31st, 2015. The Faribault County Board of Commissioners acting as the Drainage Authority for CD21 ordered an improvement on December 12th, 2016. The original contract was awarded to Northern Lines Contracting, Inc. of Bloomington, Minnesota. The Drainage Authority terminated the contract with Northern Lines Contracting, Inc. in June 2019. The defect repairs, areas that did not meet the Engineer's Plans and Specifications, were identified, and broke into 6 contracts and bid packages, 5 tile contracts/bid packages and 1 open ditch contract/bid package. The Engineer has certified the construction to repair the defects of the CD21 improvement project is complete.
