RE: Repair hearing for proposed repairs to the open ditch of County Ditch #24 (east of 338th Ave.)

Dear Landowner:

There will be a repair hearing on **Tuesday, July 13th, 2021 at 9:30 am** at the **Riverside Town and Country Club** (36259 150th St. Blue Earth, MN 56013) on Faribault County Ditch #24 (CD24). A repair petition was filed on April 5th, 2019, to address erosion and sloughing on the open ditch east of 338th Avenue in Winnebago City Township Section 9. The Engineer has submitted a repair report with repairs options for the open ditch portion of CD24. 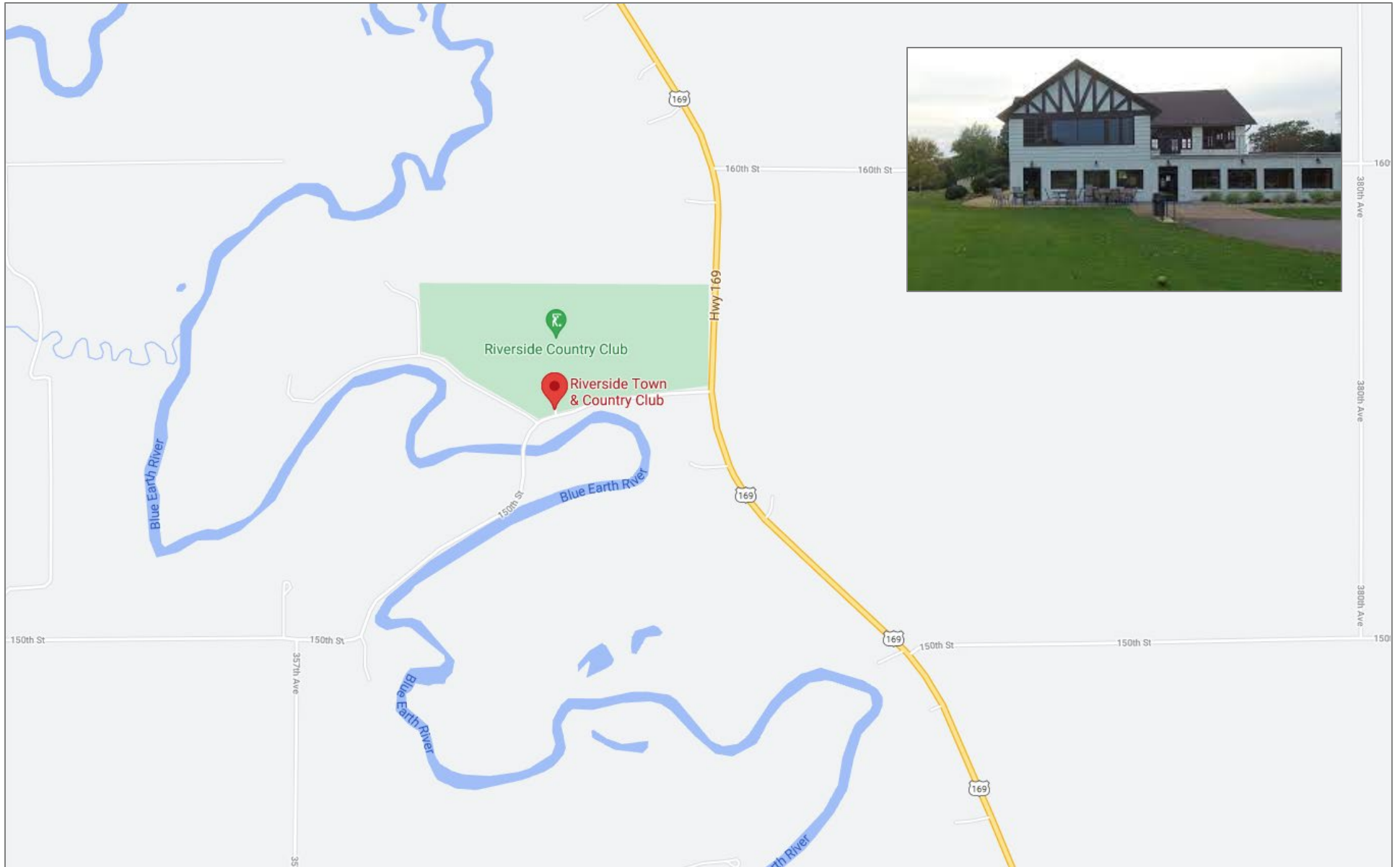

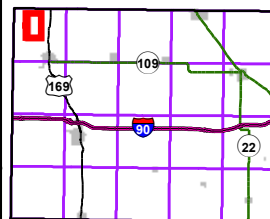
