Dear Landowner:

The Faribault County Board of Commissioners acting as the Drainage Authority for County Ditch #25A held a repair hearing on January 22nd, 2021. At the hearing, the board ordered a repair to portions of CD25A. The repair consists of replacing 850 linear feet of 24" tile with an open ditch. Bids were solicited for the repair and the project was awarded to Krueger Excavating of Albert Lea, LLC. A pre-construction meeting will be held on **Friday, June 11th, 2021 at 1:00 pm at the Golden Bubble** (11575 State Highway 22 Wells, MN 56097).

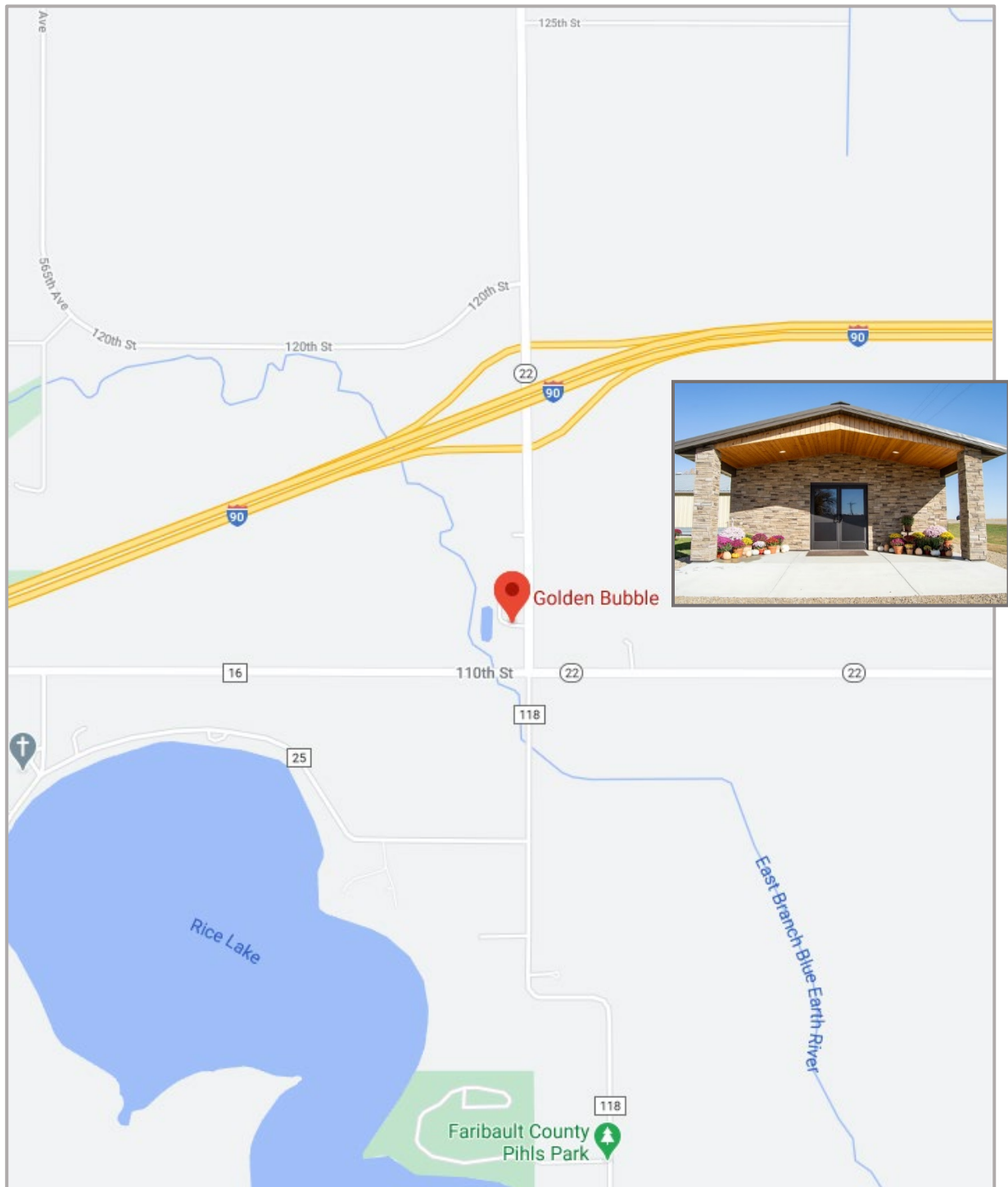
