There will be a repair hearing on **Friday, January 22nd, 2021 at 11:00 am at the Golden Bubble** (11575 State Highway 22 Wells, Minnesota 56097) on Faribault County Ditch No. 25A (CD25A). A repair petition was filed on October 28th, 2018. The repair involves a tile replacement CD25A in Section 31 of Walnut Lake Township. The Engineer filed the Repair Report on January 4th, 2021.
