There will be an informational meeting on Faribault County Ditches #26 (CD26) and #45 (CD45) held on **Thursday, August 24th at 9:00 am at the Ag Center Conference Room** (415 South Grove Street Blue Earth, MN 56013). A petition for lateral to CD26 was filed with the Faribault County Drainage Authority on March 12th, 2021. This proposed lateral to CD26 serves as the outlet to the CD45 watershed and the CD45 tile. A wetland restoration is proposed as part of the project. The Engineer has gathered further information and put together project details. This meeting will cover the proposed project. Landowners are encouraged to attend the meeting. Discussions of project scope and layout, next steps, and timeline are needed, and landowner input is important.
