There will be an informational meeting held on **Friday, January 21st, 2022, 12:30 pm at the Golden Bubble** (11575 State Highway 22 Wells, Minnesota 56097) regarding a petition for lateral the Faribault County Drainage Authority received. If you received this letter, your property is affected by this proposed project. The lateral petition was filed for Faribault County Ditch #26 (CD26). The lateral petition involves improving (upsizing) an existing private tile line that drains across multiple properties and provides an outlet to Faribault County Ditch #45 (CD45). Landowners are encouraged to attend the meeting or call the Drainage Department for information regarding the project.

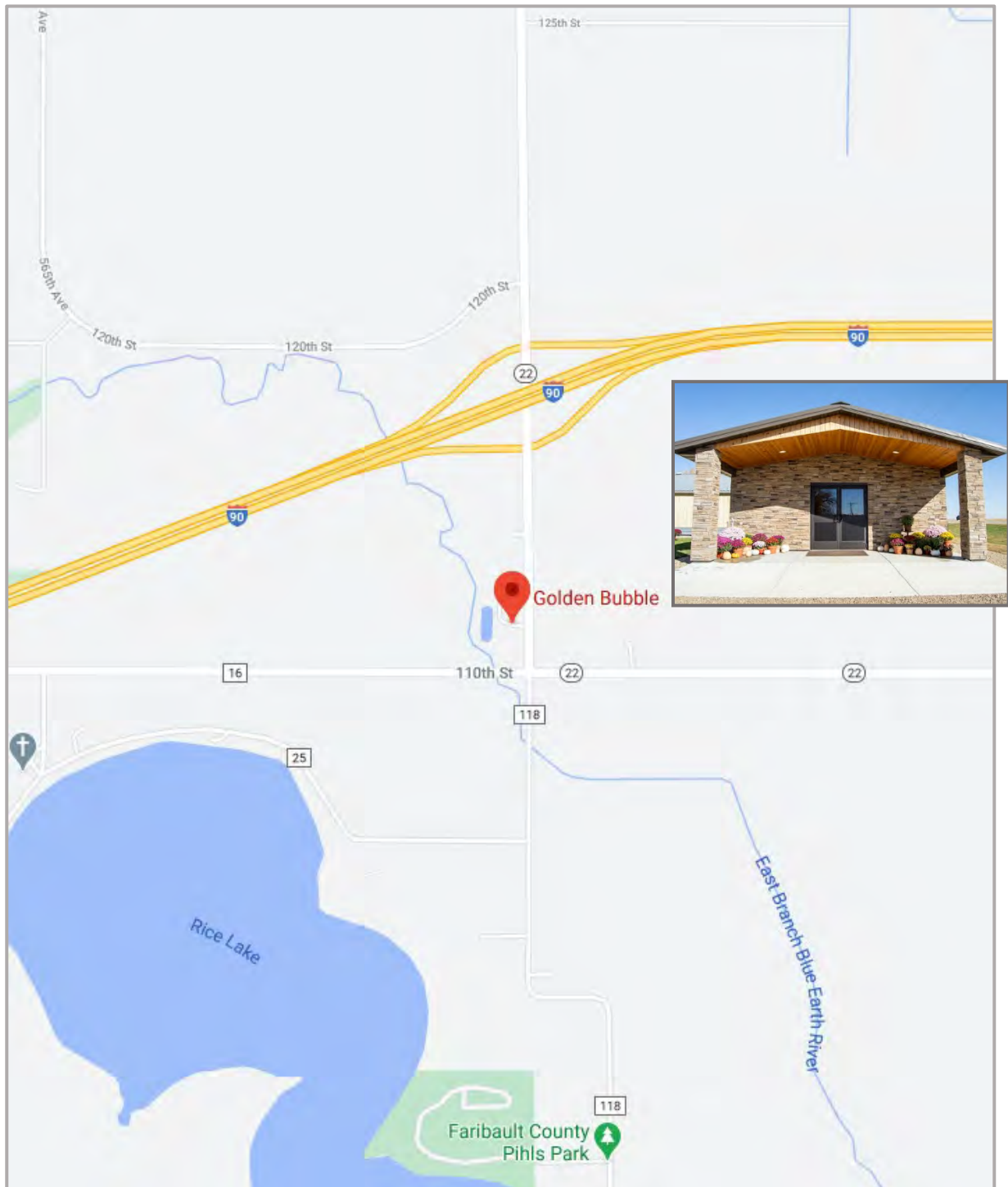




FARIBAULT COUNTY DITCH NO. 26 LATERAL PETITION
