There will be a preliminary lateral hearing on Faribault County Ditch #26 (CD26) held on **Thursday, December 8th, 2022 at 2:00 pm at the Ag Center Conference Room** (415 South Grove Street Blue Earth, MN 56013). A petition for lateral to CD26 was filed with the Faribault County Drainage Authority on March 12th, 2021. This proposed lateral to CD26 serves as the outlet to the County Ditch #45 (CD45) watershed and the CD45 tile. This meeting will cover the Engineer's Preliminary Survey Report. 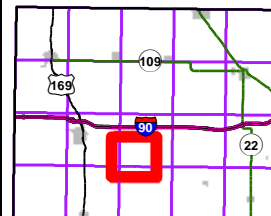
