There will be a final acceptance hearing on Faribault County Ditch No. 3 (CD3) Open Ditch Repair on Friday, January 22<sup>nd</sup>, 2021 at 9:30 am at the Golden Bubble (11575 State Highway 22 Wells, Minnesota 56097). A repair petition was filed on March 20<sup>th</sup>, 2018. The Faribault County Board of Commissioners, acting as the drainage authority for CD3, ordered repairs to CD3 open ditch on January 21<sup>st</sup>, 2020. The repairs were completed by Krueger Excavating of Albert Lea, LLC during the 2020 growing season. The Engineer has certified the repair is complete. 
