Location: Emerald Township Sections 21, 22, 23, 26, 27, 28, 34, 35

RE: Authority for County Ditch #40 to use County Ditch #46 as an Outlet

Dear Landowner:

There will be an outlet hearing on Faribault County Ditch #46 (CD46) held on Wednesday, November 17th, 2021 at 2:30 pm at the Golden Bubble (11575 State Highway 22 Wells, Minnesota 56097). A petition for County Ditch #40 (CD40) to use CD46 as an outlet was received on August 2nd, 2021. CD40 is a tile system that currently outlets to an unnamed tributary of the East Branch of the Blue Earth River through the floodplain. The CD40 tile outlet is currently under water and sediment. The unnamed tributary would be expensive to clean due to the potential wetland impacts and floodplain. The proposed project involves rerouting the CD40 tile outlet to the open ditch of CD46. 

The petition requests authority to use County Ditch #46 as an outlet for drainage from the following properties:

County Ditch #40 watershed including approximately 594 acres in portions of Sections 21, 22, 23, 26, 27, and 28 in Emerald Township (T102N R26W) Faribault County, Minnesota.

The hearing shall be held at 2:30 p.m. on November 17th, 2021, at the Golden Bubble, 11575 State Hwy 22 Wells, MN 56097. At the hearing, the drainage authority will accept public comment. All interested parties may appear and be heard.
