There will be a repair informational meeting on Faribault County Ditch #42 (CD42) held on **Friday, March 10th, 2023, at 1:00 pm at the Ag Center Conference Room** (415 South Grove Street Blue Earth, MN 56013). The Drainage Department completed an inspection and survey of CD42 in the summer/fall of 2022. The inspection and survey indicate repairs are needed to portions of the open ditch. A Staff Repair Report was completed on the recommended repairs. Landowners are encouraged to attend the meeting in-person or virtually on March 10th, 2023.

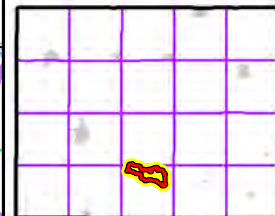


FARIBAULT COUNTY DITCH NO. 42 (CD42)
