There will be an informational meeting held on Friday, June 19<sup>th</sup>, 2020 at 1pm on Faribault County Ditch #43 (CD43). CD43 is located in Sections 16, 17, 20, 21, 27, 28, and 33 of Lura Township. An informational meeting was held on February 24th, 2020 to discuss proposed repairs to the CD43 waterway. At this meeting, several additional concerns were brought up. The Drainage Department completed further inspection and survey. This meeting will cover the additional information collected and the updated proposed repairs and associated costs.

Due to the pandemic with COVID-19, landowners can join this meeting 1 of the following 3 ways.


