There will be a repair informational meeting on Faribault County Ditch #44 (CD44) held on **Friday, March 10th, 2023, at 2:30 pm at the Ag Center Conference Room** (415 South Grove Street Blue Earth, MN 56013). Complaints of tile issues on the CD44 East Main have been reported. The Drainage Department completed an inspection and televising of CD44 East Main and found the tile to be in disrepair. A tile replacement is needed. A Staff Repair Report was completed on the recommended repairs. 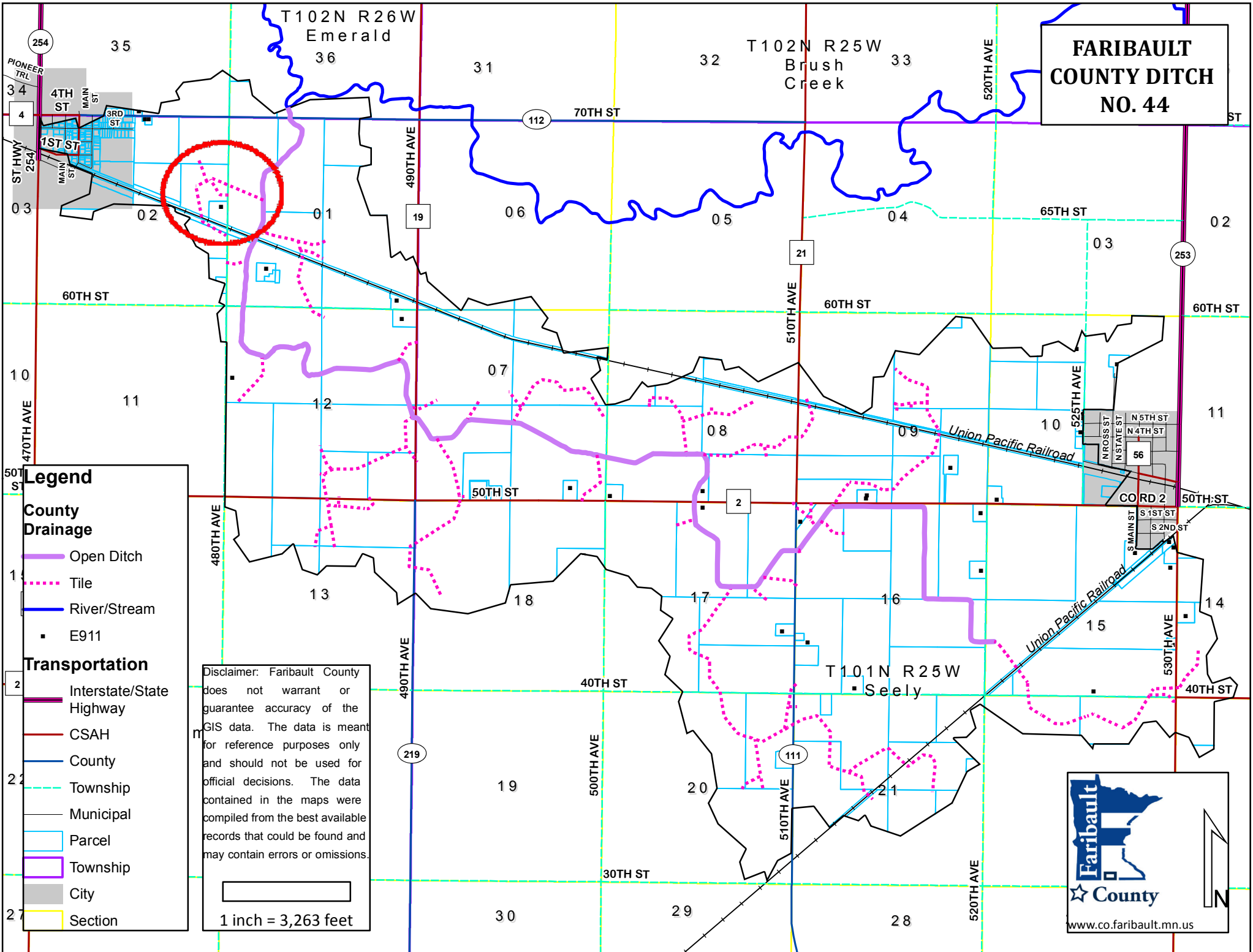
