There will be a final acceptance hearing on Faribault County Ditch #514 (CD514) Branch S Improvement on **Tuesday, December 21<sup>st</sup>, 2021 at 1:00 pm in the Board Room at the Faribault County Courthouse** (415 North Main Street Blue Earth, MN 56013). An improvement petition was filed on April 30<sup>th</sup>, 2019. The Faribault County Board of Commissioners, acting as the drainage authority for CD514, ordered an improvement to Branch S of CD514 on July 30<sup>th</sup>, 2020. The improvement was completed by Trevor Leland Drainage & Excavating in the fall of 2020. The Engineer has certified the improvement is complete. 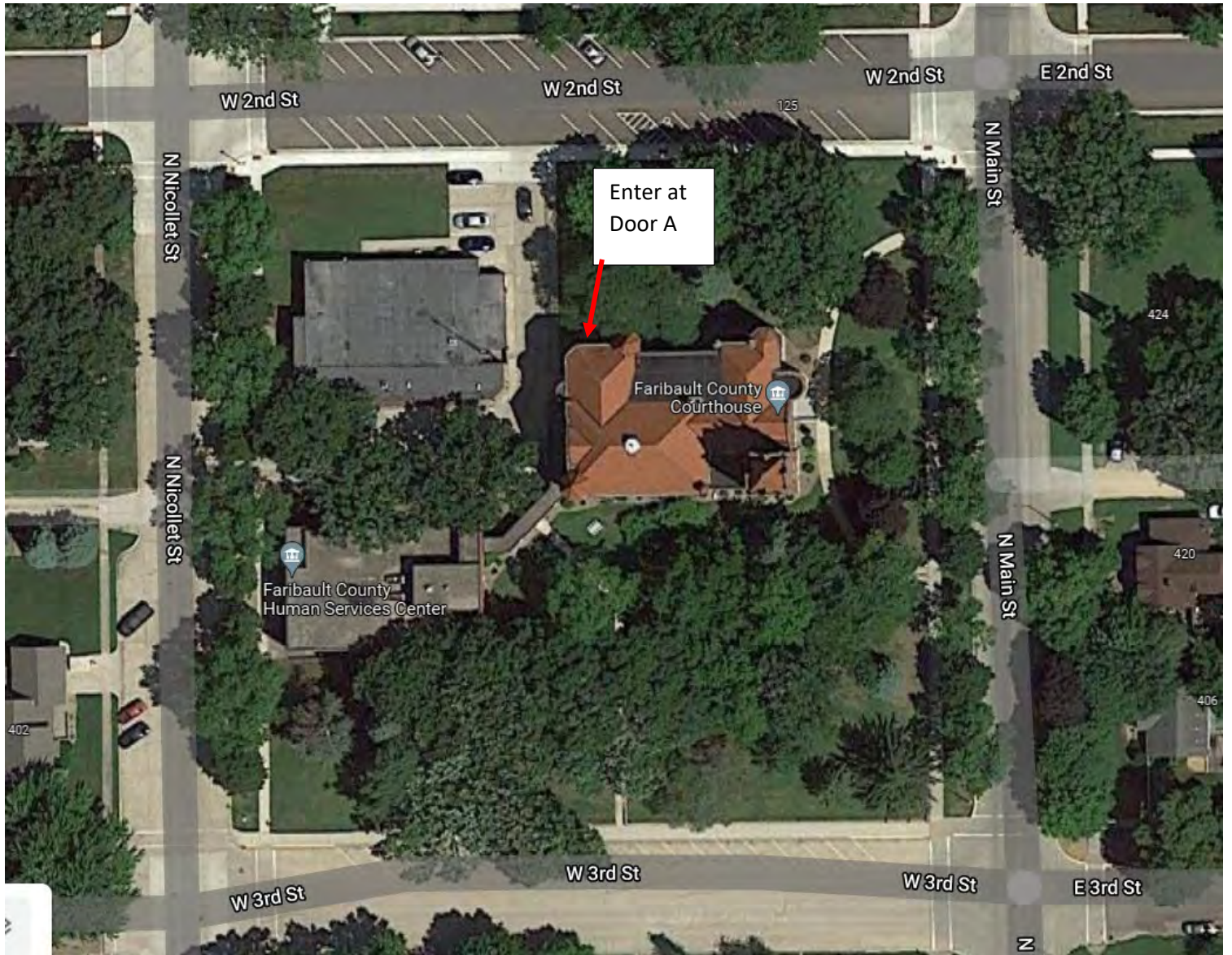
