

The proposed drainage project involves a petition for improvement to County Ditch #52. This petition upsizes tile diameters of the main and all but two branches. The project involves installation of approximately 6,954 linear feet of 8" tile, 1,706 linear feet of 10" tile, 7,943 linear feet of 12" tile, 4,874 linear feet of 15" tile, 1,427 linear feet of 18" tile, 3,294 linear feet of 24" tile, 1,522 linear feet of 30" tile, 9,192 linear feet of 36" tile, and 2,502 linear feet of 42" tile. The proposed project outlets into an unnamed tributary of the Blue Earth River in the northeast quarter of the northeast quarter of section 6 of Elmore Township.
