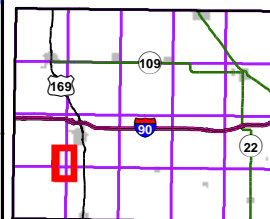

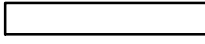
FARIBAULT COUNTY DITCH NO. 52 (CD52)
