Dear Landowner:

There will be a final acceptance hearing on Faribault County Ditch #60 (CD60) Open Ditch Repair on Tuesday, December 21st, 2021, at 11:00 am in the Board Room at the Faribault County Courthouse (415 North Main Street Blue Earth, MN 56013). A repair petition was filed on November 15th, 2018. The Faribault County Board of Commissioners, acting as the drainage authority for CD60, ordered repairs to CD60 open ditch on July 7th, 2020. The repairs were completed by Brunz Construction Company, Inc. during the 2021 growing season. The Engineer has certified the repair is complete. The Final Acceptance Report can be viewed at the Faribault County Auditor's Office or online at https://www.co.faribault.mn.us/drainage/pages/notices-reports. 
