#### Dear Landowner:

There will be final acceptance hearing on **Tuesday**, **November 17<sup>th</sup>**, **2020 at 11:30 am** on Faribault County Ditch No. 62 (CD62). Due to a Federal Disaster Event that occurred in the area on June 23<sup>rd</sup> and 24<sup>th</sup> the bioreactor system on CD62 was damaged. FEMA Public Assistance Program and Hazard Mitigation Program funding funded a repair of the system. The Engineer has certified the repair complete and a final acceptance hearing will be held. **See enclosed public notice for more information on the proceeding.**


