There will be an informational meeting held on **Monday, August 10th, 2020 at 9 am** on Faribault County Ditch No. 64 (CD64). A repair petition for open ditch cleaning and repairs was submitted on February 15th, 2018. This meeting will cover the proposed repairs, associated costs, and grant funding available.
