## FARIBAULT COUNTY DITCH #64 INFORMATIONAL MEETING NOTIFICATION

**RE:** Repair Informational Meeting

Dear Landowner:

There will be a repair informational meeting on Faribault County Ditch #64 (CD64) held on Thursday, April 27th, 2023, at 9:00 am at the Bricelyn Community Center (307 North Main Street Bricelyn, MN 56014). Concerns regarding a crossing on CD64 have been raised near the outlet of the system. The Faribault County Drainage Authority hired a certified MnDOT bridge inspector to complete an inspection of the bridge. The inspection resulted in the bridge in poor condition including a load restriction posting and replacement as soon as possible. An Engineer was hired to compile replacement options. Landowners are encouraged to attend the meeting in-person or virtually on April 27<sup>th</sup>, 2023.
