## INFORMATIONAL MEETING NOTIFICATION

To: Landowners Along Potential Lateral to County Ditch No. 72

Location: Seely Township Sections 13, 24, 25, & 36

RE: Meeting on Petition for Lateral to County Ditch No. 72

Dear Landowner:

As you may recall, a Petition for an Outlet to Faribault County Ditch No. 72 (CD72) was approved on April 10, 2019 related to the existing private ditch which passes through land you currently own. This private ditch commences in the SE ¼ SE ¼ of Section 36 in Seely Township and flows generally north before outletting into the mainline open ditch of CD72 in the NW ¼ of the SE ¼ of Section 13 of Seely Township. Various landowners now desire that the existing private ditch be converted to a lateral of the CD72 public system to assess the lands benefiting efficiently and fairly from this private ditch.

There have been multiple meetings in the past couple years about this project. There is new data to go over including updated costs and project scope, risks and statute requirements, and potential outlet fees amounts from Iowa Drainage Districts outletting into the system. There will be an informational meeting held on Friday, January 21st, 2022, at 2:00 pm at the Golden Bubble (11575 State Highway 22 Wells, Minnesota 56097) to discuss the lateral petition and get landowner feedback. Landowners are encouraged to attend to learn about the proposed petition and effects to your land. Mark Origer, a civil engineer from ISG, will be present at the meeting to review the current private ditch and public system. Attorney Bruce Sellers will be present at the meeting to review and discuss the related statutory procedures and requirements and to answer questions from landowners.
