There will be a repair informational meeting on Faribault County Ditch #73 (CD73) held on **Wednesday, March 22nd, 2023, at 1:00 pm at the Blu Bair Bar** (100 South Main Street Delavan, MN 56023). The Drainage Department completed an inspection and survey of CD73 in the summer/fall of 2022. The inspection and survey indicate repairs are needed to portions of the open ditch. A Staff Repair Report was completed on the recommended repairs. Landowners are encouraged to attend the meeting in-person or virtually on March 22nd, 2023.

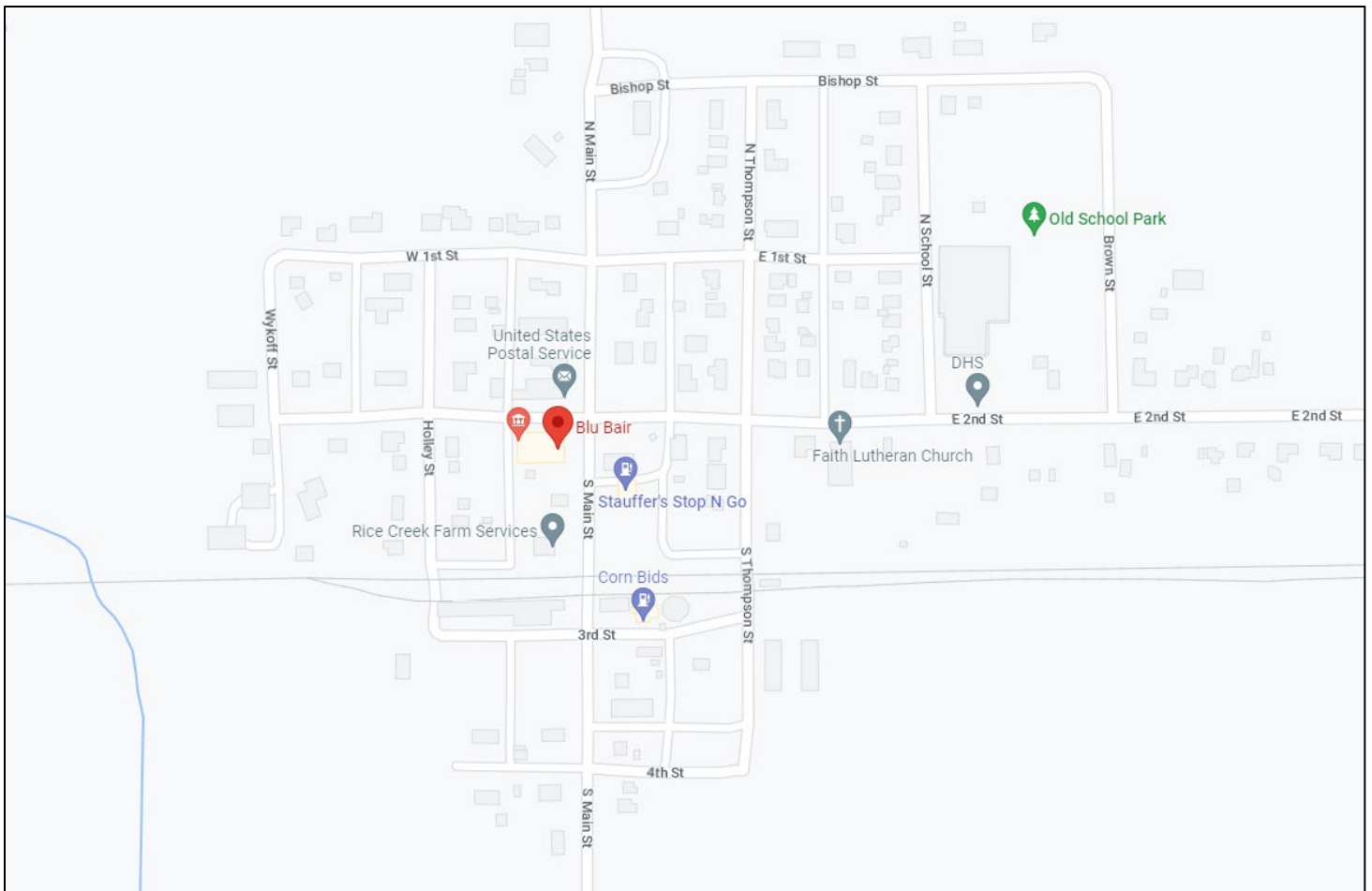

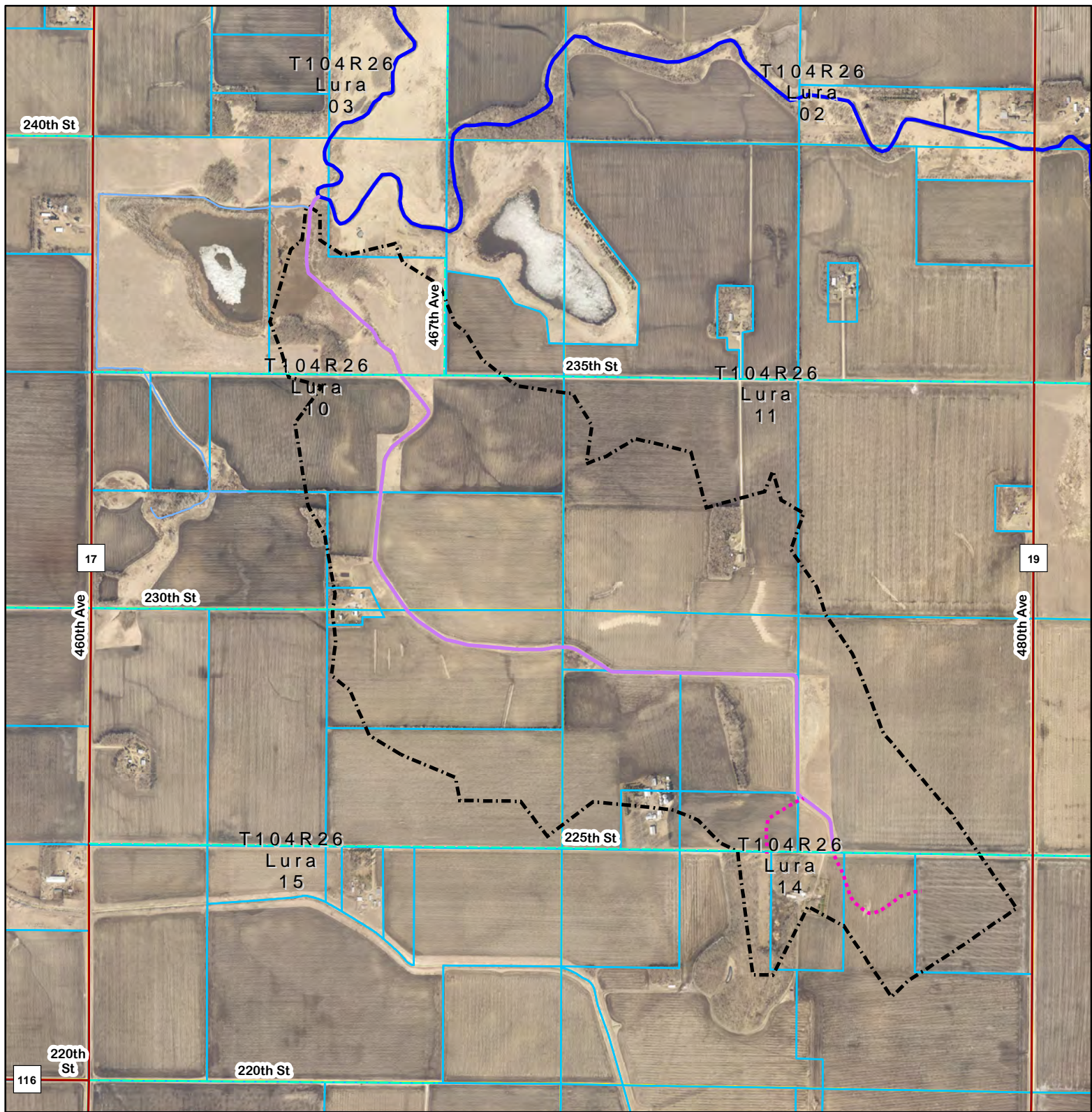
