RE: Redetermination of Benefits and Damages Final Hearing

Dear Landowner:

There will be a redetermination of benefits and damages hearing on Faribault County Ditch No. 8 (CD8) held on Thursday, January 28th, 2021 at 11:00 am at the Golden Bubble (11575 State Highway 22 Wells, Minnesota 56097). A redetermination of benefits and damages was ordered on July 3rd, 2018, due to the benefits not reflecting reasonable present-day land values and change in the benefited area. This meeting will cover the benefit and damage values. See enclosed public notice for more information on the proceeding.




