Dear Landowner:

There will be a repair hearing on **Tuesday, April 6th, 2021 at 2:00 pm at the Holiday Inn Fairmont** (1201 Torgerson Drive Fairmont, MN 56031) on Faribault and Martin Joint County Ditch #202 (JCD202FM). Inspection of JCD202FM indicates repair needs to the open ditch. The inspection was completed by drainage staff in the summer of 2020. A Staff Repair Report was completed on the recommended repairs. Landowners are encouraged to attend the hearing on April 6th, 2021. **See enclosed public notice for more information on the proceeding.**

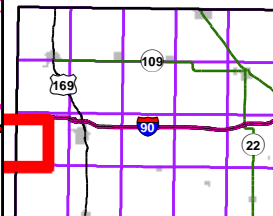
