Dear Landowner:

Martin and Faribault Joint County Ditch #214 was originally part of Joint Judicial Ditch #14. In 2007, the Drainage Authority divided the system into 4 systems: Martin and Faribault Joint County Ditch #214 (JCD214MF) (north system), Martin and Faribault Joint County Ditch #314 (JCD314MF) (middle system), Martin and Faribault Joint County Ditch #414 (JCD414MF) (south system), and Faribault County Ditch #514 (CD514) (outlet system). See the enclosed map for location reference. CD514 serves as the outlet for JCD214MF, JCD314MF, JCD414MF, Faribault County Judicial Ditch #19 (JD19F), and Faribault County Judicial Ditch #20 (JD20F).

Due to changes in the benefited area and disproportioned outlet fees on CD514, a redetermination of benefits on CD514 was ordered on February 4<sup>th</sup>, 2020. Viewers were appointed for a pending small improvement project anyways and a redetermination of the system will get everything cleared up at once. During this redetermination of benefits, the Viewers have assigned outlet benefits to JCD214MF, JCD314MF, JCD414MF, JD19F, and JD20F.

There will be an informational meeting held on **Thursday**, **July 30**<sup>th</sup>, **2020 at 8:00 am** about the JCD214MF outlet benefits to CD514. Landowners are encouraged to attend to learn the changes in outlet benefits for JCD214MF. The Viewers will be present at the meeting to answer questions from landowners.

Due to the pandemic with COVID-19, landowners can join this meeting 1 of the following 3 ways.

- 1. In person at Faribault County Courthouse Court Room (415 North Main Street Blue Earth, MN) \*Map on Back
- 2. By phone/call-in
- 3. By Zoom (internet meeting)

Social distancing will be followed if attending in person. Face masks will be required and provided. 
