Faribault and Freeborn Joint County Ditch #301 (JCD301FF) originally was Faribault County Ditch No. 1 (CD1) established in 1903. This ditch became a joint ditch draining land in Freeborn County in 1977. JCD301FF drains approximately 28,700 acres of land in Faribault and Freeborn County. JCD301FF outlets into Foster Creek just upstream of Walnut Lake in Faribault County. There was an informational meeting held on August 23rd, 2018 where landowners expressed the need for a reestablishment of records to correct incomplete records regarding the Huepper Branch.

The Joint Drainage Authority ordered a reestablishment of records on September 15th, 2020. The Engineer has filed the report. The reestablishment of records hearing will be held on Friday, December 18th, 2020 at 9:00am. Landowners are encouraged to attend. **See enclosed public notice for more information on the proceeding.**


