Dear Landowner:

There was an informational meeting held on repair options for the Hueper Branch of Faribault and Freeborn Joint County Ditch #301 (JCD301FF) on March 26th, 2021. At the meeting landowners expressed the need for replacement of the tile on the Hueper Branch due to disrepair of the tile line. Route options and township road right-of-way issues have been discussed. There will be an informational meeting held on **Tuesday, May 25th, 2021 at 9:00 am at the Wells Community Center** (189 2nd St. SE Wells, Minnesota 56097) on the updated repair plan for the Hueper Branch tile.

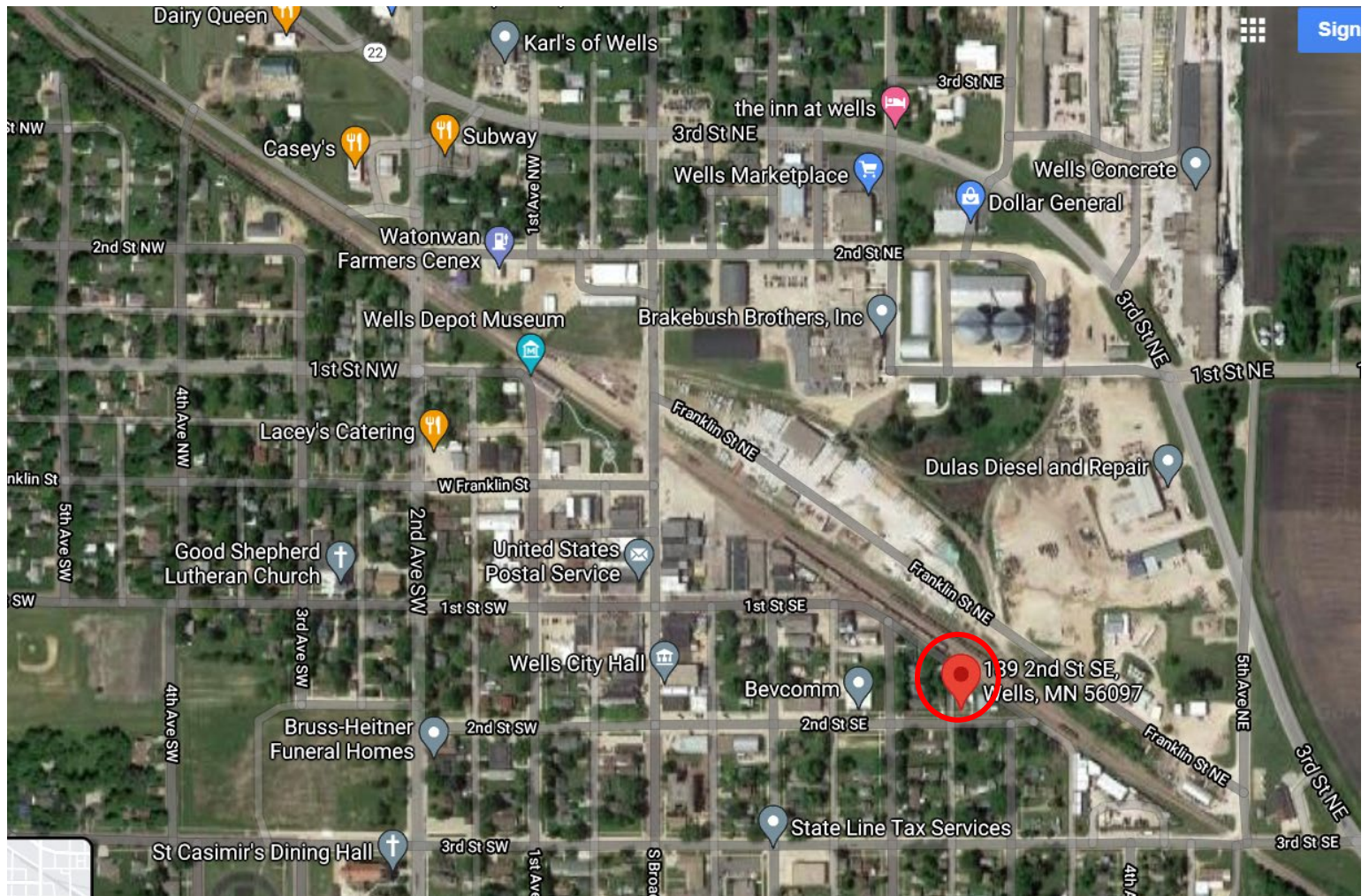

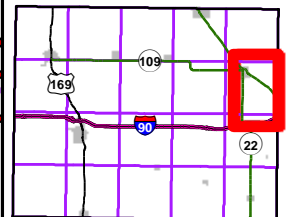



FARIBAULT JOINT COUNTY DITCH NO. 301FF (JCD301FF) HUEPER BRANCH
