System: JCD314MF

Location: Pilot Grove Township Sections 4-9

Dear Landowner:

There will be an informational meeting held on **Friday, February 21<sup>st</sup>, 2020 at 9am in the Blue Earth Ag Center Conference Room** (415 S. Grove St. Blue Earth, MN 56013) on Martin and Faribault Counties Joint County Ditch No. 314 (JCD314MF). There are drainage issues on JCD314MF that impacts property you own.

JCD314MF was originally part of Martin and Faribault Counties Judicial Ditch No. 14 (JD14MF) that was established in 1911. On November 20<sup>th</sup>, 2007 the Drainage Authority for JD14MF split the original system into 4 systems, resulting in JCD214MF, JCD314MF, JCD414MF, and CD514. JCD314MF is an all tile system that drains 3,264 acres. The outlet of JCD314MF is a 22-inch clay tile.

In 2018-2019 a repair was completed on portions of JCD314MF tile system. The downstream portion of the system is out of repair and in poor shape. The informational meeting is to discuss options and get landowner feedback on next steps for the system.
