There will be a hearing held on a petition received to outlet into Martin and Faribault Joint County Ditch #414 (JCD414MF) on **Wednesday, March 16th, 2022 at 1:00 in the Commissioner's Room at the Martin County Courthouse** (201 Lake Avenue Fairmont, Minnesota 56031 – map on back). A petition from the Jensen family to use JCD414MF as an outlet was received by the Drainage Authority. 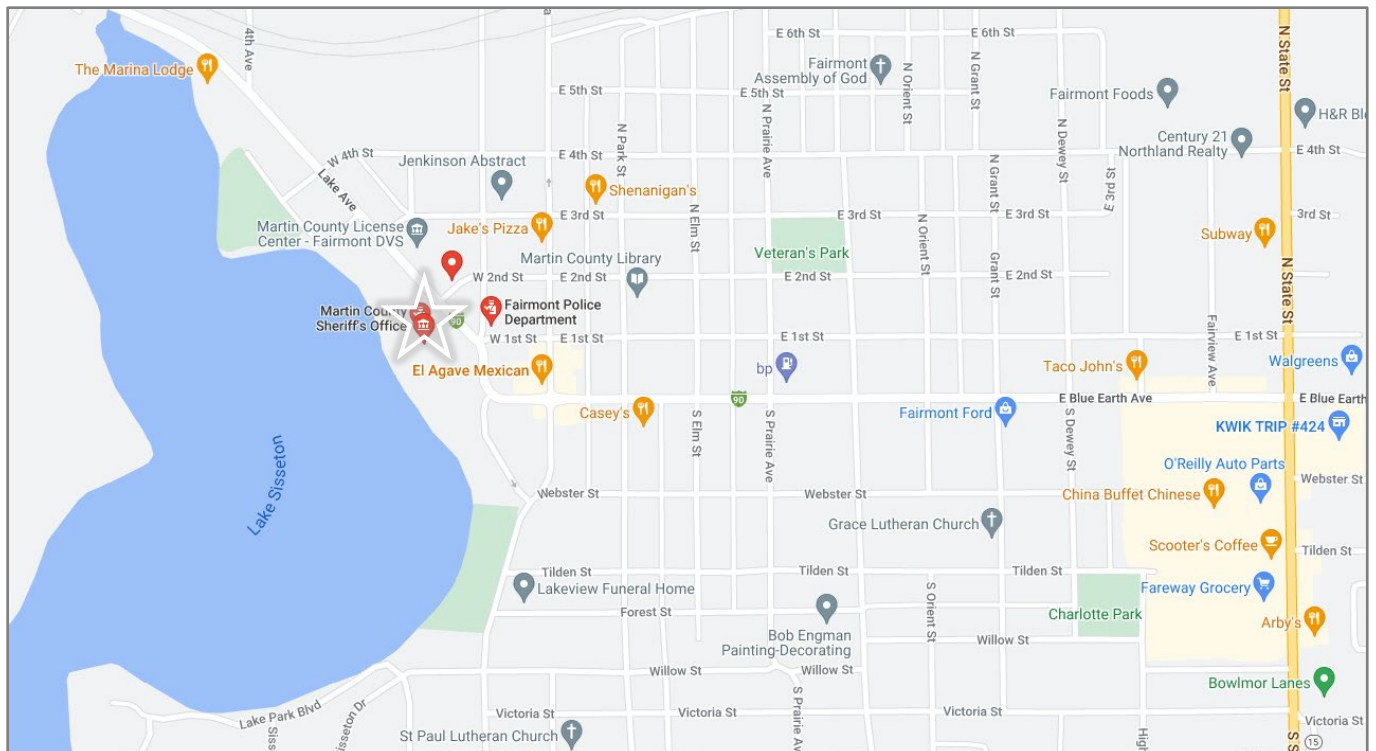
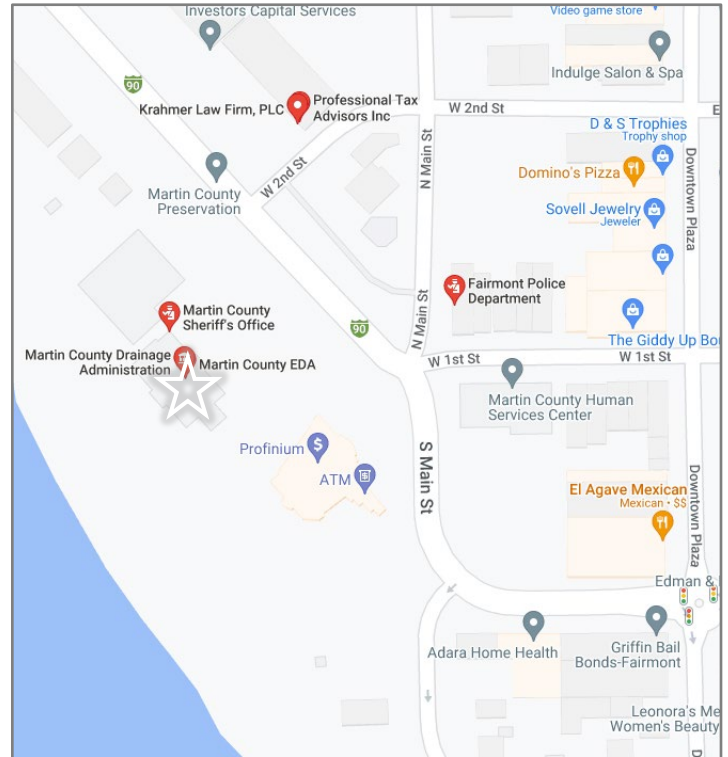
